Purchase gas and diesel with CPAFW PB#BD100437 contract 2nd year

Cooperative Purchasing Association of Fort Wayne (CPAFW) bid number PB#BD100437 - Petroleum Traders Corporation was the low bidder for Gas -Unleaded -87 Octane at \$-0.0229 off of the Oil Price Information Service (OPIS) price for the first year of the three (3) year contract and \$+0.0071 OPIS price for the next two (2) years of the contract. The contract started in April 2011. This is a joint purchase between Fort Wayne Community Schools, Allen County and the City of Fort Wayne. Within the specifications of this bid other municipalities are allowed to attach to the bid, such as Citilink. The final cost of price per gallon (PPG) will take the bid amount subtracted or added to the OPIS price plus applicable taxes. The taxes are as follows: State tax = \$.18, Inspection fee = \$.01 and the LUST fund (Leaking Underground Storage Fund) = \$.001 which totals \$.191. Total estimated cost for gas unleaded for 2012 is \$2,321,235 to be delivered to the City Garage at 1705 S. Lafayette and various City of Fort Wayne Parks Department sites. The break down for gas used at city owned fueling sites is \$1,687.901. Lassus Bros. has 26 locations throughout the city and the yearly cost is estimated at \$633,334.

Cooperative Purchasing Association of Fort Wayne (CPAFW) bid number PB#BD100437 diesel will be awarded to AG Plus for delivery of B-5 diesel and B20 diesel fuel. Transportation is also included in the pricing and is guided by OPIS pricing plus price \$+0.059, Tank Wagon price \$+0.125 per gallon (used for smaller tanks at the Parks Dept.). Total estimated cost for diesel fuel in 2012 is \$1,350,831 to be delivered to 1705 S. Lafayette and the Water Pollution Control Plant, Filtration Plant and various Park Department sites. This is the second year of a three year contract
