SECTION 1. That the SWIFT INTERCEPTOR RELIEF SEWER RES. #2425-2011, W.O. #75448 - SUPPLEMENTAL CONSTRUCTION AGREEMENT by and between SWIFT INTERCEPTOR RELIEF SEWER RES. #2425-2011, W.O. #75448 - SUPPLEMENTAL CONSTRUCTION AGREEMENT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

or (golf course) The contractor (golf course) shall furnish all labor, insurance, equipment, materials and power for the completion of the project: "Swift Interceptor Relief Sewer Restoration" as follows: Autumn Ridge Golf Course will perform the restoration on their golf course after our contractor installs approximately 3,000 LF of 30" PVC sanitary sewer.

Implications of not being approved: Autumn Ridge Golf Course has specialized equipment to perform golf course restoration along with the specific knowledge of existing conditions that will need to be met that our contractor does not possess. Our contractors generally do not perform restoration of the type and high level of intricacy that is necessary for a golf course such as Autumn Ridge. If this supplemental construction contract is not approved, then the City will have to bid out the restoration process which could be substantially more expensive. The City would take on liability it does not have if Autumn Ridge performs the restoration, and Autumn Ridge would not be able to open on time in 2012.

If Prior Approval is being Requested, Justify: This restoration is an integral part of the overall Swift Interceptor Relief Sewer project and needs to be approved simultaneously with the overall construction contract. The golf course also needs to start placing orders for materials to be delivered in time for restoration activities.

The cost of said project funded by 2010 Sewer Revenue Bond.

SUPPLEMENTAL CONSTRUCTION AGREEMENT

THIS RESTORATION AC	GREEMENT ("Agreement") is entered into this	944	day
of Avender	_, 2011, by and between Autumn Ridge Golf	Course,	Inc.,
("Autumn Ridge"), and the	City of Fort Wayne, Indiana, ("City").		

RECITALS

- A. Autumn Ridge is the owner in fee simple of certain real estate ("Real Estate") located in the City of Fort Wayne, Indiana, described in Exhibit "A", which is attached hereto and made a part of this Agreement by this reference.
- B. Autumn Ridge has agreed to grant three (3) permanent sanitary sewer easements (collectively referred to herein as the "Easement"), and three (3) temporary construction easements, (collectively referred to herein as the "Temporary Easement"), to the City across, over, under, and on top of a portion of the Real Estate in the locations and dimensions described and depicted in Exhibit "B", which is attached hereto and made a part of this Agreement by this reference, for the purposes of constructing, installing, maintaining, reconstructing, and accessing sanitary relief sewer improvements to be placed under the City's jurisdiction, control, and supervision as part of the City's public sanitary sewer system.
- C. Autumn Ridge and the City entered into a sanitary sewer easement agreement on the 18th day of October, 2011, which is recorded as document number 2011047185 in the Office of the Recorder of Allen County, Indiana.
- D. Unless otherwise approved by the parties herein, construction of the sanitary relief sewer shall be performed in accordance with the plans and specifications of Work Order No. 75448, prepared on July 29, 2011, a copy of which is hereby approved and acknowledged by Autumn Ridge, and incorporated into this Agreement.
- E. Once construction of the sanitary relief sewer improvements is complete, Autumn Ridge will restore certain portions of the Real Estate that the City disturbs during construction of the sanitary relief sewer.
- F. The City will reimburse Autumn Ridge for the cost of the restoration referenced in paragraph D above, pursuant to this agreement.

AGREEMENT

In consideration of the foregoing and the mutual covenants and agreements set forth in this Agreement, and for valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Grantor, the parties hereto agree as follows:

- 1. <u>Timing:</u> Autumn Ridge agrees not to begin restoration of any disturbed portions of the Real Estate until after the City's construction of the sanitary relief sewer improvements is complete, unless by agreement of both parties, Autumn Ridge can begin restoration without interference with the City's construction The City's construction shall be completed on the Real Estate before March 1, 2012.
- 2. <u>Ground Preparation:</u> Once construction of the sanitary relief sewer improvements on the Real Estate is complete, the City shall smooth and grade the Easement and the Temporary Easement to a condition that is acceptable for installing sod and golf cart pathways thereon.
- 3. <u>Sod:</u> Autumn Ridge shall purchase and install replacement sod on those portions of the Easement and Temporary Easement that are damaged by the City. The City shall reimburse Autumn Ridge for the purchase cost only for the sod installed on those portions of the Real Estate that are disturbed by the City, the City's agents, employees, contractors, and assigns. The City shall not pay for the repair, installation, or replacement of any sod that is not disturbed by the City, the City's agents, employees, contractors, or assigns, unless such work is made necessary to comply with paragraph nine (9) of this Agreement.
- 4. <u>Golf Cart Pathways:</u> Autumn Ridge shall pay for and repair or replace any golf cart pathways that are destroyed by the City, the City's agents, employees, contractors, or assigns. The City shall reimburse Autumn Ridge for the repair, replacement, and/or installation cost only for the golf cart pathways that are destroyed by the City, the City's agents, employees, contractors, or assigns. The City shall not pay for the repair, installation, or replacement of any golf cart pathways that are not disturbed by the City, the City's agents, employees, contractors, or assigns, unless such work is made necessary to comply with paragraph nine (9) of this Agreement.
- 5. Golf Course Hazards: Autumn Ridge shall pay for and repair or replace any sand traps or water hazards, including lakes, ponds, ditches, or streams, that are disturbed, damaged, or destroyed by the City, the City's agents, employees, contractors, or assigns. The City shall reimburse Autumn Ridge for the repair, replacement, and/or installation cost only of the sand traps and water hazards that are disturbed by the City, the City's agents, employees, contractors, or assigns. The City shall not pay for the repair, installation, or replacement of any sand traps or water hazards that are not disturbed by the City, the City's agents, employees, contractors, or assigns, unless such work is made necessary to comply with paragraph nine (9) of this Agreement.
- 6. <u>Sprinkler System:</u> Autumn Ridge shall pay for and replace any portions of the underground sprinkler system on the Real Estate that are disturbed, damaged, or destroyed by the City, the City's agents, employees, contractors, or assigns. Any portions of the sprinkler system on the Real Estate that the City moves as part of the City's construction of the relief sewer shall be moved back and re-installed by Autumn Ridge and at Autumn Ridge's cost.

- 7. <u>Trees and Other Landscaping:</u> The City may remove any trees and other landscaping on the Easement or Temporary Easement that the City deems necessary in order to construct, operate, maintain, repair, and/or reconstruct the sanitary relief sewer improvements within the Easement. The City has no duty to replace any trees or other landscaping that are removed as part of the installation of the sanitary relief sewer improvements.
- 8. No Continuing Duty: Unless otherwise indicated herein, after Autumn Ridge replaces the sod, golf cart pathway(s), sand trap(s), water hazard(s), sprinkler system(s), and other parts and appurtenances of the Real Estate (collectively referred to herein as "Golf Course Appurtenances") that are disturbed by the City, under paragraphs 1 through 7 above, and receives payment from the City, the City has no further duty, obligation, or liability to pay or reimburse Autumn Ridge for any restoration costs. If the Golf Course Appurtenances are replaced in a deficient, unstable, negligent, or other manner that makes them unfit for their intended uses, or if the Golf Course Appurtenances deteriorate or become otherwise damaged or deficient after their installation, replacement, or repair by Autumn Ridge, then the City shall have no duty, obligation, or liability to compensate Autumn Ridge for such deterioration, damage, or deficiency. Autumn Ridge assumes all liability stemming from the restoration, installation, replacement, and repair of the Golf Course Appurtenances.
- 9. <u>Restoration Condition:</u> The City will only reimburse Autumn Ridge for restoring the parts of the Real Estate disturbed by the City to the same or similar condition in which they were found immediately prior to the City's construction of the sanitary relief sewer improvements.
- 10. <u>Consideration:</u> The City agrees to pay Autumn Ridge \$430,860 for Autumn Ridge's restoration efforts on the golf course. The City will allow for a 7% contingency, or \$30,160. If this contingency is used, the total restoration cost will be \$461,020. The 7% contingency money will not be paid unless Autumn Ridge first obtains The City's approval of the quantities and cost overages and their necessity. Unless otherwise stated herein, any additional costs or expenses arising under this contract shall be the responsibility of Autumn Ridge.
- 11. <u>Payment:</u> City Utilities will make an initial payment to Autumn Ridge of \$164,020.20 within thirty (30) days of the overall expenditure's approval by the Fort Wayne City Council. The City will make three (3) additional monthly progress payments due on or before the first days of January, February and March 2012, respectively, to Autumn Ridge in the amount of \$99,000.
- 12. <u>Liquidated Damages for Delays</u>. If for any reason, including unforeseen Acts of God, the City has not completed its Construction under this agreement by March 1, 2012, the City will pay Autumn Ridge \$2,144 for each day that construction has not been completed after March 1, 2012.

- 13. <u>Settling</u>. The parties to this Agreement hereby acknowledge and understand that settling may occur in the grounds around portions of the constructed sewer line after the construction is complete and after Autumn Ridge finishes its restoration. If settling occurs within one (1) year after restoration is complete on the golf course, the City will remediate the settlement at its cost, including adding soil, smoothing, and planting or paying for the planting of new sod, or replanting the existing sod if possible to the same or similar condition in which the ground existed prior to the City's construction. Any such remediation will take place between the months of December and March unless otherwise agreed upon by the parties.
- 14. <u>Additional Damages</u>. Autumn Ridge will have the right to recover damages, including incidental and consequential damages, from the City and/or its contractors, arising from any deviation from the specifications of the construction of the sanitary relief sewer improvements referenced in this Agreement.
- 15. <u>Amendments:</u> This Agreement may only be amended by prior written consent signed by Autumn Ridge and the City.
