**AN ORDINANCE approving grants to
be funded from the Cable TV Fund.**

WHEREAS, Ordinance No. 111.34.(C).(5).a provides that a minimum of 10% of the City's Cable TV "access dollars" be set aside annually for Non-Access Channel Originator Grants for access programming by not-for-profit agencies or educational or governmental agencies within the City of Fort Wayne; and

WHEREAS, Ordinance No. 111.34.(C).(5).d provides that the Cable Fund Access Board (CFAB) recommend grant awards, with final approval granted by the Common Council from the Cable TV Fund; and
