SUBJECT: Price agreement for Liquid Sodium Hypochlorite

Dear Council Members:

Chlorination is required by IDEM (Indiana Department of Environmental Management) for disinfection of plant effluent to kill off ecoli. The plant feeds this chemical from April 1st through October 31st of each year to meet the requirements NPDES (National Pollutant Discharge Elimination System). A reverse bid was completed with 4 bidders resulting in a savings of 30% per unit in 2011. This price will be extended through 2012.
