§ 37.21 COUNCIL APPROVAL REQUIRED FOR PURCHASES AND/OR CONTRACTS FOR INSURANCE POLICIES.

- (A) (1) Whenever the city, including any city- owned or operated utility, makes any purchase of or enters into any contract for any form of insurance policy, the cost of which would exceed \$10,000 per year, all such purchases and/or contracts shall be entered into with the prior approval and subsequent ratification by the Council by ordinance or resolution duly passed by the Council and approved by the Mayor of the city.
- (2) All such purchases and/or contracts entered into without such prior approval or subsequent ratification shall be null and void.
- (3) All such purchases and/or contracts for insurance policies shall be obtained by request for proposal.
- (4) The term of any insurance acquired in accordance with this ordinance shall not exceed two years; however, said insurance may be renewed for an additional two years. Thereafter, any subsequent renewals will require a separate contract to be entered into only with the prior approval and subsequent ratification by the Council of the city.
- (B) All current purchases and/or contracts for insurance policies which have an expiration date after June 1, 1991 shall be subject to the provisions of this section upon renewal.

37-2/ -§ 37-22 PREFERENCE GIVEN TO INDIANA BUSINESSES BY AND THROUGH THE DEPARTMENT OF PURCHASING OF THE CITY OF FORT WAYNE, INDIANA

- (A) *Definitions*. This ordinance shall be referred to as the Buy Local Ordinance, and except as specifically modified herein, the definitions as set forth in IC 5-22 et seq. shall be applicable hereto.
- (1) As used in this section an *INDIANA BUSINESS* shall mean a business that is certified as an Indiana business by the Indiana Department of Administration (IDOA) and can provide proof of such certification pursuant to the disclosures required in division(B)(4)(b)below.
 - (2) An *OUT-OF-STATE BUSINESS* refers to a business that is not an Indiana business.
- (3) The *PURCHASING DEPARTMENT* as used in this section shall mean the person or entity which is considered to be the purchasing agent of the City of Fort Wayne.
