13	SECTION 1. That Section 97.21 (A) of the Code of Ordinances of the City of
14	Fort Wayne, Indiana, be amended and approved as follows:
15	§97.21 POSSESSION, SALE OR CONSUMPTION OF
16	ALCOHOLIC BEVERAGES.
17	(A) No intoxicants of any kind, including wine, beer, ale,
18	or other alcoholic beverages, shall be brought into a
19	park area, consumed, sold or given away on the premise
20	of any public park, parkway or boulevard strip, except
21	the Botanical Conservatory, the Fort Wayne Children's Zoo, the Foster Park Golf Course Pavilion, Headwaters
22	Park, the Community Center, the Foellinger Theater,
23	Freimann Square, Salomon Farm Park, the Old Fort, the
24	Wells Street Bridge, and Robert E. Myers Park; and
25	then only with a prior written permit to do so having been
26	received from the Department and the Indiana Alcohol
27	and Tobacco Commission.

SUBJECT: Amendment /City Ordinance 97.21 (A)- Possession, Sale or Consumption

of Alcoholic Beverages

DATE: April 10, 2012

The Wells Street Bridge is a Parks and Recreation Facility which can be reserved for exclusive use. Rental fees were approved at the November 17, 2011 Park Board Meeting: \$100.00/daily rental OR \$50.00/two hour rental.

Ten other Parks and Recreation facilities were previously approved by the Park Board for alcohol use under "Special Use Policy" guidelines and are "exceptions" in the current City Ordinance 97.21 (A).

The following "Special Use Policy" guidelines for alcohol use on the Wells Street Bridge were presented and approved at the March 14, 2012 Park Board Meeting:

- A. User Group will obtain a \$25.00 Special Use Permit from Parks and Recreation's Administrative Office
- B. User Group will obtain an <u>Alcohol and Tobacco Commission Permit</u> (ATC) **OR** use a caterer defined as "a state licensed beer, liquor, and wine restaurant permit holder who is authorized to dispense alcoholic beverages off their licensed premises" This does not include liquor stores or drug stores that have a three way license.
- C. Permits must be clearly posted at the event.
- D. Alcohol must be served by a licensed bartender.
- E. Alcohol must be contained on the Wells Street Bridge. (Security will enforce)
- F. Uniformed security will be scheduled by the Parks Special Events Coordinator and paid by the user group.
- G. User group is responsible for scheduling, delivery, removal and payment of portable restroom facilities (porta-johns), waste receptacles, and waste removal sufficient for the size of their event as determined by park staff. Porta-johns and waste receptacles will be located in the grass area at the northeast corner of the bridge (between the bridge and greenway path).

At the same meeting the Park Board approved amending City Park Ordinance 97.21 (A) adding "Wells Street Bridge" to the list of areas where alcohol is allowed.
