To amend Ordinance Z-7-12 to the correct multiple family zoning designation

of RP-Planned Residential from R3-Multiple Family Residential

Related Petitions:

Effect of Passage:

Ordinance Z-7-12, Rezoning Petition 1270/12 contained an error in the heading. The ordinance read "R3-Planned Multiple Family Residential" where it should have read "RP-Planned Residential". All other paperwork for this project, including legal notices, courtesy letters and public notice signs were correctly identified with RP zoning. The only incident of the incorrect zoning was on the ordinance itself. This rezoning was for the Keller Development senior apartments at Reservation Drive and Bluffton Road. The public hearing presentation correctly identified the proposed zoning and there was no opposition to the project.

Effect of Non-Passage:

The Plan Commission recommended approval to RP-Planned Residential and the Council discussion and approval was for an RP designation, as presented by staff. The project can still proceed under the R3 designation but this will not be consistent with how the project was presented to the Plan Commission, Council and the public.
