2 **GENERAL ORDINANCE NO. G-_____**

3 **AN ORDINANCE OF COMMON COUNCIL OF**
4 **THE CITY OF FORT WAYNE, INDIANA**
5 **REPEALING ALL OF SECTION 32.02 OF THE**
6 **FORT WAYNE CODE OF ORDINANCES OF**
7 **THE CITY OF FORT WAYNE AND**
8 **REPLACING IT WITH A NEW SECTION 32.02**
9 **OF SAID CODE,**

10 **WHEREAS,** Indiana Code Section 36-4-6-3 allows for redistricting or re-
11 division into six (6) Councilmanic Districts for the City of Fort Wayne at any time
12 so long as I.C. 3-11-1.5-32 is complied with, which statute prescribes, among other
13 things, that no division shall be made after November 8th of the year preceding the
14 year in which a municipal election is to be held, and before the day following the
15 date on which the municipal election is held except to assign territory to a municipal
16 legislative body district in an annexation ordinance; and

17 **WHEREAS,** Common Council believes it is necessary to periodically
18 redistrict, and/or re-divide the six (6) Councilmanic Districts due to shifts in
19 population and/or annexations.

20 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON**
21 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

22 **SECTION 1.** That Section 32.02 of the Fort Wayne Code of Ordinances is
23 hereby repealed in its entirety and is replaced with the following:

24 **§ 32.02 COUNCILMANIC DISTRICTS**

25 **(A)** The City is hereby divided and there are hereby established the
26 following Councilmanic Districts:

(5) City Councilmanic District No. 5 shall consist of the following precincts, which are presently numbered by the Allen County Election Board as follows;

(6) City Councilmanic District No. 6 shall consist of the following precincts, which are presently numbered by the Allen County Election Board as follows;

SECTION 2. Subsequent to the passage of this section, the Allen County Election Board shall file with the City Clerk a legal description of the territory comprised of the above-listed precincts in each Councilmanic District, which legal description shall remain on file in the Office of the City Clerk. Additionally, the Allen County Election Board shall renumber, as necessary, all precincts located in each City Councilmanic District in consecutive order, and a list of the numbered precincts in each Councilmanic District shall likewise be filed with the City Clerk. The legal description of any territory annexed to the city included in each City Councilmanic District and any newly created numbered precincts included in said territory shall be placed on file with the Office of the City Clerk by the Allen County

1 Election Board as amendments to the legal descriptions of said Councilmanic
2 Districts and to the list of precincts included in said Councilmanic District on file in
3 said Office.

5 **SECTION 3.** Attached hereto and marked "Exhibit A" and made a part of
6 this Ordinance is a map showing the new boundaries of each Councilmanic District
7 in the City of Fort Wayne.

8 **SECTION 4.** That this Ordinance shall be in full force and effect from and
9 after its passage and any and all necessary approval by the Mayor.
