AN ORDINANCE approving the awarding of ITB #3533-ASH TREE REMOVAL FOR 2012 by the City of Fort Wayne, Indiana, by and through its Department of Purchasing and COOK'S TREE SERVICE for the PARKS AND RECREATION DEPARTMENT.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA;

SECTION 1. That ITB #3533-ASH TREE REMOVAL FOR 2012 between the City of Fort Wayne, by and through its Department of Purchasing and COOK'S TREE SERVICE for the PARKS AND RECREATION DEPARTMENT, respectfully for:

removal of 4500 ash trees and stumps throughout the City of Fort Wayne;

involving a total cost of FIVE HUNDRED SIXTY-EIGHT THOUSAND, SIX HUNDRED TEN AND 00/100 DOLLARS (\$568,610.00) all as more particularly set forth in said ITB #3533-ASH TREE REMOVAL FOR 2012 which is on file in the Office of the Department of Purchasing, and is by reference incorporated herein, made a part hereof, and is hereby in all things ratified, confirmed and approved.
