AN ORDINANCE AMENDING SECTION 72.99 PENALTY –
TO INCLUDE SECTION 72.22(S) STOPPING, STANDING
OR PARKING PROHIBITED IN SPECIFIED PLACES
REGARDING TRAFFIC REGULATIONS OF THE CITY OF
FORT WAYNE, INDIANA, CODE OF ORDINANCES

WHEREAS, the City of Fort Wayne, Indiana ("City") has clarified and expanded an existing regulation governing the enforcement of parking restrictions in the Citizens Square Parking Lot at 220 E. Berry St.; and

WHEREAS, Section 72.22 of the City of Fort Wayne, Indiana, Code of Ordinances has been amended to include Section 72.22(S) regarding the Citizens Square Parking Lot parking restrictions; and

WHEREAS, an amendment is necessary to establish a penalty for the enforcement of Section 72.22(S) of the City of Fort Wayne, Indiana, Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the following Section 72.99 (A) (1) of the City of Fort Wayne, Indiana, Code of Ordinances is hereby amended to include the penalty for violation of the parking restriction in Citizens Square Parking Lot as follows:

AMEND:

§ 72.99 (A)(1) Sections 72.22(S),72.46 and 72.61. If the violator appears in response to a notice affixed to such motor vehicle within a period of 30 calendar days from the date and time shown on said notice affixed to such motor vehicle, the penalty shall be \$5. If the violator fails to appear in response to a notice affixed to such motor vehicle after 30 calendar days from the date and time shown on said notice affixed to such motor vehicle the penalty shall be \$10.

SECTION 2. Except for the foregoing amendments, the remaining sections of Section 72.99 of the City of Fort Wayne, Indiana, Code of Traffic Regulations shall remain in full force and effect.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.
