2 GENERAL ORDINANCE NO. _____

3 **AN ORDINANCE AMENDING SECTION 72.99 PENALTY –**
4 **TO INCLUDE SECTION 72.22(S) STOPPING, STANDING**
5 **OR PARKING PROHIBITED IN SPECIFIED PLACES**
6 **REGARDING TRAFFIC REGULATIONS OF THE CITY OF**
7 **FORT WAYNE, INDIANA, CODE OF ORDINANCES**

8 **WHEREAS**, the City of Fort Wayne, Indiana ("City") has clarified and
9 expanded an existing regulation governing the enforcement of parking
10 restrictions in the Citizens Square Parking Lot at 220 E. Berry St.; and

11 **WHEREAS**, Section 72.22 of the City of Fort Wayne, Indiana, Code of
12 Ordinances has been amended to include Section 72.22(S) regarding the
13 Citizens Square Parking Lot parking restrictions; and

14 **WHEREAS**, an amendment is necessary to establish a penalty for the
15 enforcement of Section 72.22(S) of the City of Fort Wayne, Indiana, Code of
16 Ordinances.

17 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
18 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

19 **SECTION 1.** That the following Section 72.99 (A) (1) of the City of
20 Fort Wayne, Indiana, Code of Ordinances is hereby amended to include the
21 penalty for violation of the parking restriction in Citizens Square Parking Lot
as follows:

22 **AMEND:**

23 **§ 72.99 (A)(1)** Sections 72.22(S), 72.46 and 72.61. If the violator
24 appears in response to a notice affixed to such motor vehicle within a period
25 of 30 calendar days from the date and time shown on said notice affixed to
26 such motor vehicle, the penalty shall be \$5. If the violator fails to appear in
27 response to a notice affixed to such motor vehicle after 30 calendar days
28 from the date and time shown on said notice affixed to such motor vehicle
29 the penalty shall be \$10.

SECTION 2. Except for the foregoing amendments, the remaining sections of Section 72.99 of the City of Fort Wayne, Indiana, Code of Traffic Regulations shall remain in full force and effect.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.
