SPECIAL ORDINANCE NO. _____

**AN ORDINANCE OF THE CITY OF FORT WAYNE COMMON COUNCIL
DECLARING PUBLIC CONVENIENCE AND NECESSITY REQUIRE
ACQUISITION OF CERTAIN UTILITY ASSETS AND THE ADDITION OF
THOSE ASSETS AND FACILITIES TO FORT WAYNE CITY UTILITIES
AND AUTHORIZING THE CITY TO MAKE AN OFFER TO THE OWNER
OF THOSE ASSETS PURSUANT TO IC 8-1.5-2 AND AUTHORIZING THE
CITY TO EXERCISE ITS AUTHORITY PURSUANT TO IC 32-24-1 TO
CONDEMN THE ASSETS IF THE OFFER IS REJECTED AND GOOD
FAITH NEGOTIATIONS FAIL**

WHEREAS, the City of Fort Wayne ("City") is a political subdivision and municipality organized and operating under the laws of the State of Indiana; and

WHEREAS, it is the intent of the Common Council of the City of Fort Wayne ("Council") to protect and advance the health, safety, welfare and wellbeing of its citizens, utility users, and the community; and

WHEREAS, local municipalities such as the City are often uniquely situated to account and provide for the best interests of the community, citizens, and users through the provision of utility services; and

WHEREAS, the City has a municipal utility, Fort Wayne City Utilities ("FWCU"), that provides certain services; and

WHEREAS, the City has received requests from its citizens, utility users, and the community for relief from Aqua Indiana Inc. ("Aqua Indiana"), a water utility provider; and

WHEREAS, those requests have been received from many neighborhoods located inside the City including: Winterfield/Indian Reserve Community Association, Aboite Lakes Estates Association, Covington Homesteads Condominium Association, Parke Condominium Owner Association, Inverness Hills Neighborhood

1 Association, Barrington Woods Neighborhood Association, Kekionga Shores
2 Community Association, Sheffield Woods, Covington Reserve-Phase III, Sycamore
3 Hills Community Association, Covington Place, Abbey Place Villas, Coventry
4 Villas, Chestnut Hills Apartments, Aboite Meadows, Covington Lake Estates,
5 Amber Ridge Estates and Haverhill Community Association, said requests are
6 attached hereto as Appendix A; and

7 WHEREAS, those requests have been received from many neighborhoods located
8 outside the City including: Aurora Coves, Calera, Hamilton Pointe Apartments and
9 the neighborhoods of Azbury, said requests are attached hereto as Appendix B; and
10

11 WHEREAS, pursuant to Ind. Code 8-1.5-2 and other applicable statutes, the City
12 may own, acquire, and thereafter operate existing utilities; and

13 WHEREAS, the Council deems it desirable and in the best interests of the City to
14 exercise its legal authority to acquire, and thereafter own and operate certain existing
15 water facilities of Aqua Indiana, generally described as the water utility assets
16 serving the southwest portion of the City and nearby portions of Allen County and
17 Whitley County outside the boundaries of the City (the "Aqua Indiana Southwest
18 Utility"), for the purpose of providing water service within and surrounding the
19 City's municipal limits and its extraterritorial authority; and

20 WHEREAS, a public convenience and necessity will be advanced by the acquisition
21 of the Aqua Indiana Southwest Utility and the expansion of FWCU, and that such
22 public convenience and necessity will be advanced by thereafter acquiring, owning
23 and operating those assets and facilities; and

25 WHEREAS, the Council has determined that, pursuant to IC 32-24-1 *et seq.* the City
26 should present Aqua Indiana with an offer to purchase Aqua Indiana's Southwest
27 Utility; and

1 WHEREAS, the Council has also determined, pursuant to IC 8-1.5-2 *et seq.* and IC
2 32-24-1 *et seq.*, that if Aqua Indiana rejects the City's offer to purchase the Aqua
3 Indiana Southwest Utility, and if the City determines that good faith negotiations
4 between the City and Aqua Indiana regarding the purchase have failed, then the City
5 is authorized to condemn the Aqua Indiana Southwest Utility; and

6 WHEREAS, the Council has caused to be delivered to Aqua Indiana notice that the
7 Council would hear public testimony regarding this Ordinance at 5:30 on January 22,
8 2013, in the Citizens Square, Room 35 (Garden Level), 200 E. Berry Street, Fort
9 Wayne, Indiana, 46802 and said notice informed Aqua Indiana that it could appear in
10 person or by counsel to testify regarding this Ordinance; and

11 WHEREAS, the Council did in fact permit public testimony on this Ordinance at
12 5:30 on January 22, 2013 in the Citizens Square, Room 35 (Garden Level), 200 E.
13 Berry Street, Fort Wayne, Indiana, 46802.

14
15 NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of
16 Fort Wayne, Indiana, as follows:

17
18 **SECTION 1.** The above recitals are incorporated herein by this reference as though
19 fully set forth herein below.

20
21 **SECTION 2.** Council hereby declares that public convenience and necessity exists
22 and requires, and the public interest will be served by, acquisition of the Aqua
23 Indiana Southwest Utility and the addition of those utility assets and facilities to
24 FWCU, the City's existing municipal utility.

25
26 **SECTION 3.** Council hereby authorizes the City, pursuant to IC 32-24-1 *et seq.*, to
27 present Aqua Indiana with an offer to purchase the Aqua Indiana Southwest Utility.

SECTION 4. The City hereby exercises its power to acquire and thereafter own, operate, and control the assets and facilities comprising the Aqua Indiana Southwest Utility for the purpose of providing water service both inside and outside the City's municipal limits.

SECTION 5. If Aqua Indiana rejects the purchase offer and the City determines that good faith negotiations between the City and Aqua Indiana regarding the purchase have failed, Council hereby authorizes the City to exercise its legal authority to condemn the Aqua Indiana Southwest Utility pursuant to IC 8-1.5-2 *et seq.* and IC 32-24-1 *et seq.*

SECTION 6. By passing this Ordinance, the City has been authorized to exercise its power to condemn the Aqua Indiana Southwest Utility.

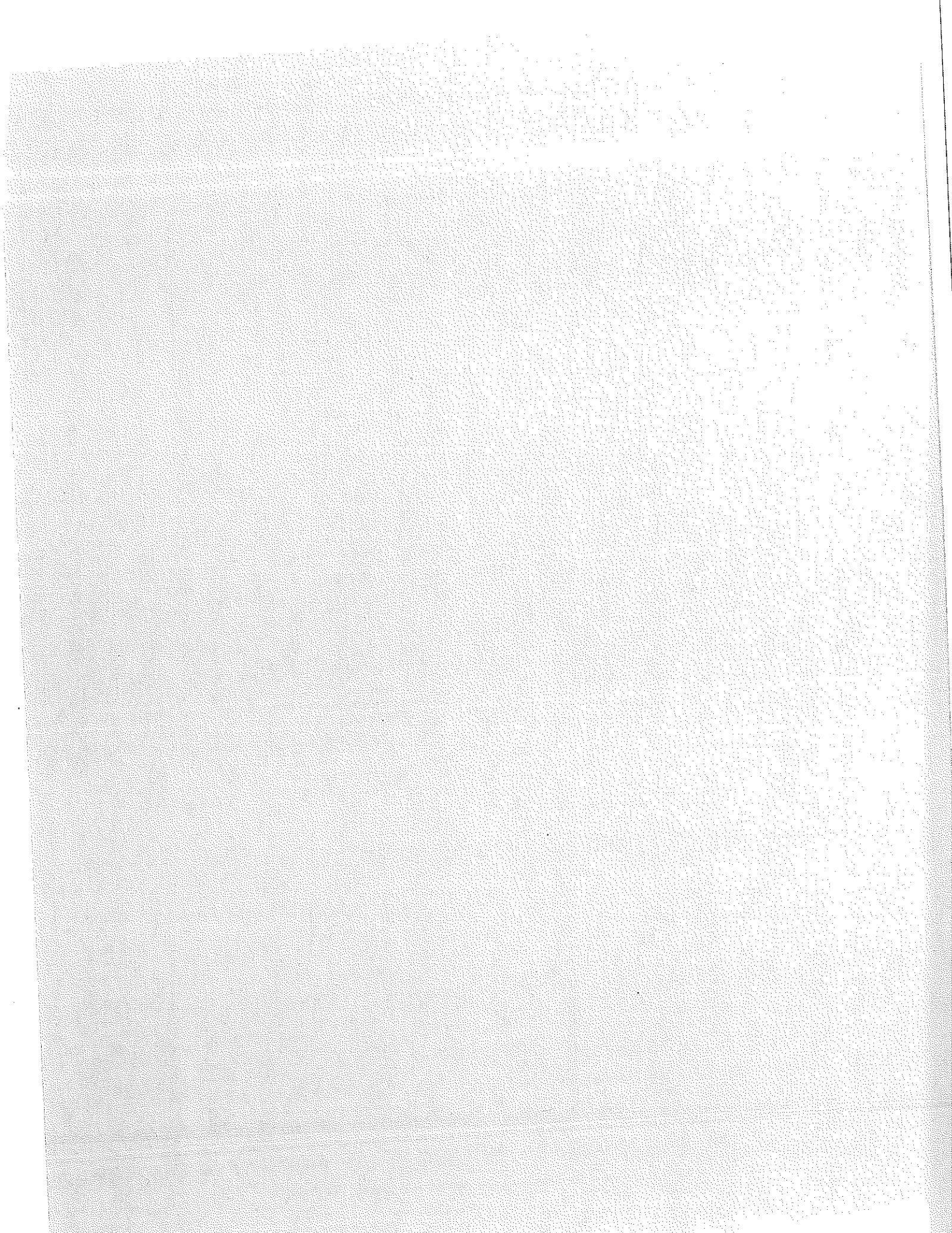
SECTION 7. The terms, paragraphs, sentences, words and actions of this Ordinance are separable, and if any portion of this Ordinance or its acts is found to be unconstitutional, invalid or unenforceable, any such determination shall not affect the remaining terms or portions of the Ordinance and related actions of the City and Council.

SECTION 8. This Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.

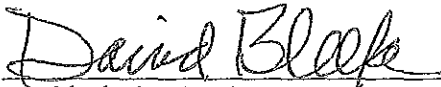
Dear Mayor Henry:
