

This bid covers insurance from 7/14/13 to 7/14/14 for the stated value for the City of Fort Wayne properties of \$735,446,425.00. The premium recommendation is from The Hartford for \$424,500 for both Commercial Property and Boiler/Equipment Breakdown. This is compared to \$425,559 last year with Travelers for a stated value of \$733,422,340; a savings of \$1,059 for increased coverage.
