In regards for the used chip spreader Please award to Southeastern Equipment for a Total cost of \$130,000 with trade in.

We have the opportunity to purchase a used Etnyre chipper box a 2009 model used by the street department trading in unit #58385 a 1988 model.

Southeastern Equipment had this unit that came from a private company that they traded in on a new unit. The City demoed and used this unit for a couple of days. Some Improvements over current unit

- Computer control for application/material rate and speed control
- Variable width chipping capabilities from 10' to 18' current unit is a 12' front hopper only
- Hydraulic gates operator able to open and shut off from station with electric switch
- Folding rear hopper making it easier to clean out stone box
- Automatic conveyor speed controls
- Front hopper vibrator shakes the stone down so it does not clump up.
- Power Operator control station making it easier to move from left to right when in tight areas

With the variable widths it makes it easier to change widths at the operator station as street changes widths around approaches. Current unit have to stop and do manually.

Cost of a new unit with the same type of specs cost \$233,100
