#### ZONING MAP ORDINANCE NO. Z-\_\_\_\_

AN ORDINANCE amending the City of Fort Wayne Zoning Map No. K-50 (Sec. 10 of Washington Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the area described as follows is hereby designated An RP (Planned Residential) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

Part of the Northeast quarter, Section 10, Township 31 North, Range 12 East in Allen County, by metes and bounds described as follows, to-wit:

Commencing on the North line of said quarter section at a point situated 383 feet East of the North quarter corner of said section; thence East on the North line of said quarter section, a distance of 1920 feet to a point situated 4 chains West of the Northeast corner of said section; thence South and parallel to the East line of said quarter section 659.4 feet to the Southeast corner of the Louisa Garber Lot in the plat of the subdivision of the Estate of Thomas Badiac as recorded in Deed Record 108, pages 17-21; thence West on the South line of said Louisa Garber Lot and coincident with the North line of Beverly Heights Addition as recorded in Plat Book 11, pages 16-17 in the office of the Recorder of said county, a distance of 2162.5 feet to point situated 152 feet East of the centerline of the public highway known as the Lima Road; thence North and parallel to the said road center line a distance of 329.6 feet: thence East and parallel to the South line of said Louisa Garber Lot, a distance of 231 feet to a point 330 feet East of the East line of right-of-way of the former Toledo Chicago Interurban Railway; thence North and parallel to the aforesaid right-of-way line 334 feet to point of beginning; containing 30.94 acres of land.
