AN ORDINANCE amending the City of Fort Wayne Zoning Map No. H-42 (Sec. 16 of Washington Township)

ZONING MAP ORDINANCE NO. Z-

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the area described as follows is hereby designated an R1 (Single

Family Residential) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

Part of the Northwest Quarter of Section 16, Township 31 North, Range 12 East of the Second Principal Meridian, Washington Township in Allen County, Indiana, more particularly described as follows:

Commencing at a chiseled "X" at the Northeast corner of said Northwest Quarter; thence South 88 degrees 50 minutes 12 seconds West (GPS Grid bearing and basis of bearings to follow), a distance of 1225.46 feet along the North line of said Northwest Quarter and within the right-of-way of Cook Road to the East line of the Northwest Quarter of said Northwest Quarter; thence South 01 degrees 14 minutes 42 seconds East, a distance of 50.00 feet along said East line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set on the South line of an existing 0.669 acre tract described in Document Number 2008002856 in the Office of the Recorder of Allen County, Indiana, said point also being the POINT OF BEGINNING of the herein described tract; thence continuing South 01 degrees 14 minutes 42 seconds East, a distance of 532.86 feet along East line to a 5/8" steel rebar found on the centerline of the Brown No. 2 Legal Drain; thence North 70 degrees 19 minutes 50 seconds West, a distance of 115.11 feet along said centerline; thence North 76 degrees 40 minutes 22 seconds West, a distance of 95.60 feet along said centerline; thence North 88 degrees 02 minutes 45 seconds West, a distance of 117.85 feet along said centerline; thence North 85 degrees 00 minutes 16 seconds West, a distance of 118.92 feet along said centerline; thence South 89 degrees 07 minutes 08 seconds West, a distance of 161.41 feet along said centerline; thence South 87 degrees 28 minutes 35 seconds West, a distance of 115.70 feet (deed) along said centerline to a point on the East line of an existing tract described in Document Number 2011011791 in the Office of the Recorder of Allen County, Indiana, said point being referenced by a 5/8" steel rebar with a "Tazian" identification cap found 0.24 feet South and 0.51 feet West; thence North 00 degrees 44 minutes 48 seconds West, a distance of 280.78 feet (deed) along said East line and parallel with the West line of said Northwest Quarter to a 6" steel post found at the Southwest corner of an existing tract described in Document Number 990040488 in the Office of the Recorder of Allen County, Indiana; thence North 88 degrees 50 minutes 12 seconds East, a distance of 150.00 feet (deed) along said South line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set on the East line of said Document Number 990040488; thence North 00 degrees 44 minutes 48 seconds West, a distance of 165.00 feet along said East line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set on the South line of said 0.669 acre tract;

thence North 88 degrees 50 minutes 12 seconds East, a distance of 133.62 feet (deed) along said South line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set; thence South 77 degrees 06 minutes 23 seconds East, a distance of 102.85 feet (deed) along said South line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set; thence North 88 degrees 50 minutes 12 seconds East, a distance of 125.78 feet (deed) along said South line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set; thence North 01 degrees 14 minutes 42 seconds West, a distance of 30.00 feet along said South line to a 5/8" steel rebar with a "Miller Firm #0095" identification cap set; thence North 88 degrees 50 minutes 12 seconds East, a distance of 200.00 feet (deed) along said South line to the Point of Beginning. Containing 6.918 Acres, more or less. Subject to the right-of-way of the Brown No.2 Legal Drain and subject to easements of record. and the symbols of the City of Fort Wayne Zoning Map No. H-42 (Sec. 16 of Washington Township), as established by Section 157.082 of Title XV of the Code of the City of Fort Wayne, Indiana is hereby changed accordingly.
