AN ORDINANCE amending the City of Fort Wayne Zoning Map No. I-30 (Sec. 21 of Washington Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE.

SECTION 1. That the area described as follows is hereby designated an IN2 (General Industrial) District under the terms of Chapter 157 Title XV of the Code of the City

A 3.977 Acre parcel located in the Southeast Quarter, Section 21, Township 31 North, Range 12 East, Washington Township, Allen County, Indiana; and more

Commencing as an Indiana State Highway right-of-way monument, located at the intersection of the West line of the East half of the Southeast Quarter of Section 21, Township 31 North Range 12 East and the North right-of-way of Coliseum Boulevard (now State Road 930, formerly U.S. Highway 30 and California Road). Said right-of-way monument being located at 125 feet left of Station 44+30 as shown on Sheet #13 of the highway plans for the 1973-1974, U.S. 30 Highway Project U-174 (20). Thence North 79 deg. 22 min. 49 sec. West along the Notherly right-ofway of Coliseum Boulevard (Indiana Highway #930), a distance of 50.95 feet; thence North 00 deg. 28 min. 25 sec. West, a distance of 25.00 feet; thence North 80 deg. 23 min. 16 sec. West, a distance of 18.00 feet to an Iron Pin (rebar) with Surveyors Cap 'Russell Associates' marking the POINT OF BEGINNING; Thence North 81 deg. 56 min. 36 sec. West, a distance of 97.17 feet; thence South 87 deg. 19 min. 18 sec. West, a distance of 36.22 feet to a point; thence North 00 deg. 31 min. 52 sec. West, a distance of 926.52 feet to an 'I-Beam' fence post (3 ½" x 7"); thence North 89 deg. 00 min. 25 sec. East, a distance of 200.00 feet to a point on the East line of the West Half of the Southeast Quarter of said Section 21; thence South 00 deg. 32 min. 48 sec. East, a distance of 736.21 feet; thence South 89 deg. 17 min. 48 sec. West, a distance of 11.16 feet; thence South 00 deg. 27 min. 49 sec. East, a distance of 2.26 feet to a manhole; thence South 89 deg. 18 min. 00 sec. West, a distance of 56.56 feet; thence South 00 deg. 28 min. 25 sec. East, a distance of 202.65 feet to the POINT OF BEGINNING; Containing 3.977 Acres.

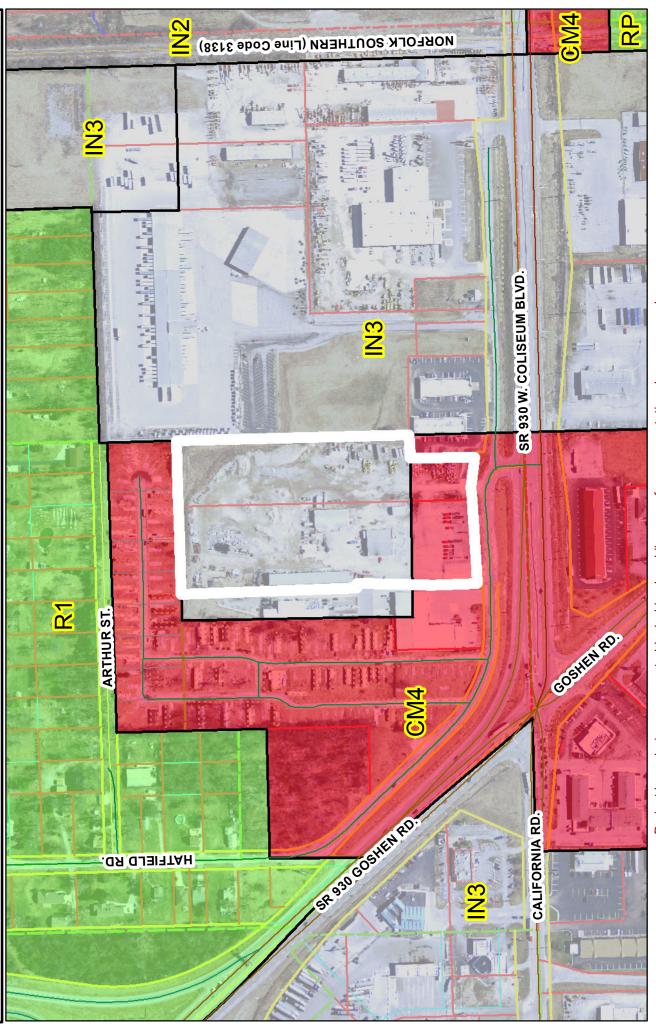
