

G-5 AN ORDINANCE amending the Thoroughfare 6 Plan of the City Comprehensive ("Master") Plan by vacating public right-of-way. 7 WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as 8 more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, 9 Indiana: and 10 WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing 11 and approved said petition, as provided in I.C. 36-7-3-12. 12 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF 13 FORT WAYNE, INDIANA: 14 SECTION 1. That the petition filed herein to partially vacate a public right-of-way within the 15 City of Fort Wayne, Indiana, more specifically described as follows, to-wit: 16 A twelve foot wide north-south alley located along the west property line of Lot 14 and Lot 15 in McLachlin Addition to Mechanicsburg, as recorded in Deed Book 45, page 195, in the 17 Office of the Recorder of Allen County, more particularly described as follows: 18 Beginning at the northwest corner of Lot 14 in said McLachlin Addition to Mechanicsburg, as recorded in Deed Book 45, page 195, in the Office of the Recorder of Allen County; thence 19 southerly a distance of 112 feet to the Southwest corner of Lot 15 in said McLachlin Addition to Mechanicsburg; thence westerly a distance of 12 feet to the Southeast corner of Lot 6 in 20 said McLachlin Addition to Mechanicsburg; thence northerly a distance of 112 to the Northeast corner of Lot 7 in said McLachlin Addition to Mechanicsburg; thence easterly a 21 distance of 12 feet to the point of beginning. Together with: 22 A twelve foot wide north-south alley located along the east property line of Lots 1, 2, and 3 of Lehmans Addition to the City of Fort Wayne, as recorded in Plat Book 8, page 95 in the Office 23 of the Recorder of Allen County, more particularly described as follows: 24 Beginning at the Northeast corner of Lot 1 in said Lehmans Addition to the City of Fort Wayne, as recorded in Plat Book 8, page 95 in the Office of the Recorder of Allen County; 25 thence easterly a distance of 12 feet to the southwest corner of Lot 15 in McLachlin Addition to Mechanicsburg, recorded in Deed Book 45, page 195, in the Office of the Recorder of Allen 26 County: thence southerly, along the east line of the alley to be vacated, a distance of 82.5 feet to a point on the north line of the east-west alley running along the north property line of Lot 27 21 in Fleming and Esmonds Addition to the City of Fort Wayne, as recorded in Deed Book 104, page 617 in the Office of the Recorder of Allen County; thence westerly a distance of 12 28 29


