AN ORDINANCE approving CONSTRUCTION CONTRACT - 2015 - RESURFACING PACKAGE SOUTHEAST - RESOLUTION #0046A between BROOKS CONSTRUCTION and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. 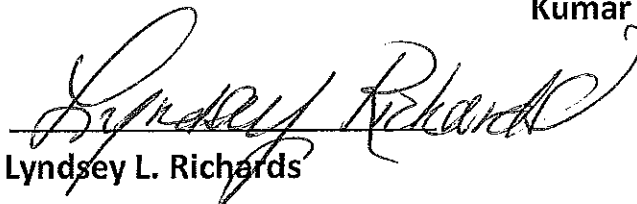
