RESOLUTION NO. R-

A RESOLUTION approving a Waiver of Noncompliance for a Late-Filed Application for the Deduction from Assessed Valuation of Structures in Economic Revitalization Areas (Form 322/RE) for 530 Home Avenue, Fort Wayne, Indiana 46807 (Fairfield Community Home, LP)

WHEREAS, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution property at 530 Home Avenue for Fairfield Community Home, LP (Confirming Resolution R-9-13) under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and

WHEREAS, the original Statement of Benefits and economic revitalization area designation application submitted by Fairfield Community Home, LP and approved under Confirming Resolution R-9-13 was for \$5,170,282 in real property improvements; and

WHEREAS, construction of the real property improvements for Fairfield Community Home, LP was completed in December 2013; and

WHEREAS, representatives of Fairfield Community Home, LP have informed the City of Fort Wayne that their application for deduction from assessed valuation of structures in economic revitalization areas (322/RE) for 2015 was not filed in a timely manner; and

WHEREAS, this oversight was an unusual occurrence for Fairfield Community Home, LP; and

WHEREAS, the Common Council finds that Fairfield Community Home, LP has fulfilled its pledge to construct the real property improvements; and

WHEREAS, Fairfield Community Home, LP has created its workforce as reported on the approved statement of benefits forms; and

WHEREAS, the Common Council acknowledges that Fairfield Community Home, LP has requested a waiver of non compliance which the Common Council has the power and authority to approve, under I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3; and

WHEREAS, the Common Council intends that Fairfield Community Home, LP receive the tax abatement benefits to which they would have been entitled had no non compliance event occurred, so long as the waiver of non compliance and the granting of those benefits does not prejudice the City of Fort Wayne; and

WHEREAS, the Common Council has concluded that granting of the ERA deduction for 2015 payable 2016 tax year would not create a strain on the City of Fort Wayne's fiscal budget; and
