A RESOLUTION approving a Waiver of Noncompliance for a Late-Filed Application for the Deduction from Assessed Valuation of Structures in Economic Revitalization Areas (Form 322/RE) for 701 Sherman Boulevard, Fort Wayne, Indiana 46808 (Becky's Die Cutting, Inc./Garrison, LLC)

WHEREAS, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution property at 701 Sherman Boulevard for Becky's Die Cutting, Inc./Garrison, LLC (Confirming Resolution R-93-14) under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and

WHEREAS, the original Statement of Benefits and economic revitalization area designation application submitted by Becky's Die Cutting, Inc./Garrison, LLC and approved under Confirming Resolution R-93-14 was for \$150,000 in real property improvements; and

WHEREAS, construction of the real property improvements for Becky's Die Cutting, Inc./Garrison, LLC was completed in December 2014; and

WHEREAS, representatives of Becky's Die Cutting, Inc./Garrison, LLC have informed the City of Fort Wayne that their application for deduction from assessed valuation of structures in economic revitalization areas (322/RE) for 2015 was not filed in a timely manner; and

**WHEREAS,** this oversight was an unusual occurrence for Becky's Die Cutting, Inc./Garrison, LLC; and

WHEREAS, the Common Council finds that Becky's Die Cutting, Inc./Garrison, LLC has fulfilled its pledge to construct the real property improvements; and

**WHEREAS,** Becky's Die Cutting, Inc./Garrison, LLC has created its workforce as reported on the approved statement of benefits forms; and

WHEREAS, the Common Council acknowledges that Becky's Die Cutting, Inc./Garrison, LLC has requested a waiver of noncompliance which the Common Council has the power and authority to approve, under I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3; and

WHEREAS, the Common Council intends that Becky's Die Cutting, Inc./Garrison, LLC receive the tax abatement benefits to which they would have been entitled had no noncompliance event occurred, so long as the waiver of noncompliance and the granting of those benefits does not prejudice the City of Fort Wayne; and

13	SECTION 2. As authorized by I.C. 6-1.1-12.1-9.5(d), the Common Council will permit	
14	Becky's Die Cutting, Inc./Garrison, LLC to receive the real property economic revitalization area deductions for 2015 payable 2016 under Confirming Resolution R-93-14. The Allen	
15	County Auditor and Allen County Assessor shall be supplied with a copy of this Resolution,	
16	upon passage, and instructed to apply the deduction amounts in accordance with this	
17	schedule. This resolution shall have no effect on the assessed value, tax abatement deductions or taxes payable with respect to Becky's Die Cutting, Inc./Garrison, LLC's	
18	personal property.
