**AN ORDINANCE APPROVING GRANTS TO BE
FUNDED FROM THE CABLE TV FUND.**

WHEREAS, Ordinance No. 111.34.(C).(5).a provides that a minimum of 10% of the City's Cable TV "access dollars" be set aside annually for Non-Access Channel Originator Grants for access programming by not-for-profit agencies, educational or governmental agencies within the City of Fort Wayne; and

WHEREAS, Ordinance No. 111.34.(C).(5).d provides that the Cable Fund Access Board (CFAB) recommend grant awards, with final approval granted by the Common Council from the Cable TV Fund; and

WHEREAS, the Cable Fund Access Board recommends the following Non-Access Channel Originator Grant awards from the Cable TV Fund:

Subject: Cable TV Non-Access Channel Originator Grants

Members of City Council:

This ordinance is to authorize the payment of grants totaling \$131,999.94 for access programming by not-for-profit agencies, governmental groups and educational groups which do not originate access channels. This is the list of grantees and the amount received:

This money comes from the Cable Franchise fee collected by the City of Fort Wayne. By local ordinance 111.34, ten percent of the "access dollars" are designated for Non-Access Channel Originator Grants, subject to approval by City Council. Any funds not utilized for grants must remain in the fund for use the following year.

The budget for non-access originator grants is \$132,000, which is 10% of "access dollars" and 4% of the total franchise fees collected in the previous four quarters. In addition to funding cable channels and these grants, Cable

Franchise Fees also provide about \$1.6 million dollars to the City's general fund every year.
