RESOLUTION NO. R-

A RESOLUTION determining SUBSTANTIAL COMPLIANCE OR NON-COMPLIANCE with a Statement of Benefits (SB-1) for 2016 for CK Products, LLC at 6230 Innovation Boulevard under Confirming Resolution R-35-11 with an "Economic Revitalization Area" approved under I.C. 6-1.1-12.1

WHEREAS, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution with approved Statement of Benefits (SB-1) forms property for CK Products, LLC as an "Economic Revitalization Area" under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and

WHEREAS, property owners whose Statement of Benefits (SB-1) form was approved after July 1, 1991 who file a deduction application under Sections 3 and 4.5 of I.C. 6-1.1-12.1 and Section 153.21 of the Municipal Code of the City of Fort Wayne, Indiana, must file a Compliance with Statement of Benefits Form (CF-1) with the Allen County Auditor, the Allen County Assessor and the City of Fort Wayne showing information on the extent to which there has been compliance with the approved Statement of Benefits for the project; and

WHEREAS, CK Products, LLC has filed Compliance with Statement of Benefit Forms with the Allen County Assessor's Office, Allen County Auditor's Office and the City of Fort Wayne; and

WHEREAS, CK Products, LLC's approved Statement of Benefits (SB-1) form stated that 40 full-time jobs would be created and 88 full-time and 1 part-time jobs would be retained by December 2015; and

WHEREAS, CK Products, LLC's approved Statement of Benefits (SB-1) form stated \$1,224,704 in annual payroll would be generated from the 40 full-time created jobs and \$2,390,995 in annual payroll would be generated from the 88 full-time and 1 part-time jobs; and

WHEREAS, CK Products, LLC's 2016 Compliance with Statement of Benefits (CF-1) form filing stated that 20 full-time jobs were created and 88 jobs were retained; and

WHEREAS, CK Products, LLC's 2016 Compliance with Statement of Benefits (CF-1) form filing stated \$522,496 in annual payroll for the 20 full-time jobs created and \$2,990,142 in annual payroll for the 88 jobs retained; and

WHEREAS, Common Council designated the City of Fort Wayne Community Development Division as the entity for the administration, application, processing and monitoring of Economic Revitalization Areas under Section 153.13 of the Municipal Code of the City of Fort Wayne; and

WHEREAS, Common Council has defined substantial compliance under Section 153.21 of the Municipal Code of the City of Fort Wayne as:

- Meeting 75% or more of the numbers of full-time and/or part-time jobs stated to be created or retained as delineated in the original Statement of Benefits Form (SB-1) approved by Common Council; and
- Meeting 75% or more of the total payroll stated to be created or retained as delineated in the original Statement of Benefits Form (SB-1) approved by Common Council; and

WHEREAS, meeting 75% of the 40 created means creating 30 full-time jobs and of the 89 retained jobs retaining 66 jobs; and

WHEREAS, meeting 75% of the \$1,224,704, in annual payroll to be created means \$918,528 in annual payroll created; and

WHEREAS, meeting 75% of the **\$2,390,995** in annual payroll retained means **\$1,793,246** in annual payroll retained; and

WHEREAS, Common Council shall determine not later than forty-five (45) days after receipt of the Compliance of Statement of Benefits Form (CF-1) that CK Products, LLC has substantially complied with the original Statement of Benefits Form (SB-1) approved by Common Council; and

WHEREAS, CK Products, LLC appeared/failed to appear before council to provide additional information on its compliance with statement of benefits.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That, Common Council finds that the Compliance with Statement of Benefits Form (CF-1) filed by CK Products, LLC with an approved economic revitalization area for 2016 is not in substantial compliance pursuant to I.C. 6-1.1-12.1 and Section 153.21 of the Municipal Code of the City of Fort Wayne for failure to create 75% of the \$1,224,704 or \$918,528 in annual payroll from the 40 jobs or 30 jobs that were stated that would be created.

SECTION 2a. CK Products, LLC appeared before council and provided additional information on its compliance with statement of benefits and from this information it was determined that notwithstanding CK Products, LLC's failure to substantially comply by its failure to create \$918,528 or more in annual payroll from 30 jobs or more created, that CK Products, LLC did make reasonable efforts to substantially comply with the statement of

1 benefits and CK Products, LLC's failure to substantially comply was caused by factors beyond the control of CK Products, LLC. Therefore, the continuation of CK Products, LLC's 2 deduction/abatement under R-35-11 is hereby approved. 3 SECTION 2b. That CK Products, LLC appeared and provided additional information on its compliance with statement of benefits and from this information it was 4 determined that notwithstanding CK Products, LLC's failure to substantially comply by its 5 failure to create \$918,528 or more in annual payroll from the 30 or more jobs created, that 6 CK Products, LLC did not make reasonable efforts to substantially comply with the statement of benefits and CK Products, LLC's failure to substantially comply was not caused by factors 7 beyond the control of CK Products, LLC. Council therefore directs the Community 8 Development Division to mail written notice to CK Products, LLC explaining the reasons for Council's determination and a date, time, place of a hearing to be conducted by Council for 9 the purpose of further considering CK Products, LLC's 2016 compliance with statement of 10 benefits. 11 **SECTION 2c.** That CK Products, LLC failed to appear and otherwise provide additional information on its compliance with statement of benefits and has caused Council to 12 conclude and find that CK Products, LLC is not in substantial compliance pursuant to I.C. 6-13 1.1-12.1 and Section 153.21 of the Municipal Code of the City of Fort Wayne on their 2016 14 filing. Council therefore directs the Community Development Division to mail written notice to CK Products, LLC explaining the reasons for Council's determination and a date, time, place 15 of a hearing to be conducted by Council for the purpose of further considering CK Products, 16 LLC's 2016 compliance with statement of benefits. DEPARTMENT REQUESTING ORDINANCE: Community Development Division

SYNOPSIS OF ORDINANCE: This resolution determines whether Compliance with Statement of Benefits (CF-1) Form filings made by CK Products, LLC in May 2016 with an approved economic revitalization area are in substantial compliance pursuant to both Council policy and Indiana law.

EFFECT OF PASSAGE: Will allow property owners with existing economic revitalization area designation to continue to receive their economic revitalization area deduction (property tax abatement/phase-in) benefit if determined to be in substantial compliance or provide notice to company if determined to be in substantial non-compliance and a hearing will be scheduled

EFFECT OF NON-PASSAGE: Potential retention or loss of economic revitalization area deduction (property tax abatement/phase-in)
