GENERAL ORDINANCE NO. G-____

AN ORDINANCE amending the Thoroughfare Plan of the City Comprehensive ("Master") Plan by vacating public right-of-way.

Beginning at the Northeast corner of Lot 86 in the Plat of Sand Point Gardens, Section A, as recorded in Plat Book 13A, Page 38, in the Office of the Recorder of Allen County, Indiana, thence Westerly along the North line of Lots 86, 85, 84, 83, 82, 81, 80, 79, 78 and 77, a distance of 500 feet to the Northwest corner of Lot 77; thence Northerly to the North line of the right-of-way of Vernon Avenue, a distance of 50 feet; thence Easterly along the north right-of-way line of Vernon Avenue, a distance of 500 feet; thence Southerly, a distance of 50 feet to the point of beginning, containing 0.57 acres of land, more or less.




