Highland Gospel Community Church (Gospel Community Inc) is requesting the vacation of this right of way for the safe use of the property by the members of our church. Vehicles turning left from driving southbound on North Clinton Street onto this section of Parkhill Avenue frequently travel at a high rate of speed. The risk to our congregation was highlighted on January 13, 2016 when a driver involved in an accident fled the scene and traveled down this section of Parkhill Avenue and crashed into a vehicle parked at our church along Parkhill Avenue. This occurred at a time when AWANA, a popular children's outreach ministry, was taking place at our church. Highland Gospel Community Church has purchased the properties on the east side of Parkhill Avenue (lots 55 - 60) with the intent of expanding our campus and foot traffic from our church building (lots 63 – 66) across Parkhill Avenue will increase. For this reason, Highland Gospel Community church is requesting the City of Fort Wayne to vacate the public right of way of this portion of Parkhill Avenue.
