GENERAL ORDINANCE NO. G-

AN ORDINANCE amending the Thoroughfare Plan of the City Comprehensive ("Master") Plan by vacating public right-of-way.

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

Beginning at the Northeast corner of Lot 57, Hiron's Addition, being a subdivision in the South Half of Section 24, Township 30 North, Range 12 East, City of Fort Wayne, Indiana, according to the plat thereof recorded in Plat Book 6, page 69, Allen County Records; thence North 88 degrees 10 minutes 15 seconds East on the South right-of-way line of East Fairfax Street 14 feet to the Northwest corner of Lot 47 of said Hiron's Addition; thence South 33 degrees 46 minutes 35 seconds East on the West line of Lots 47 through 51 of said Hiron's Addition 244.64 feet to the Southwest corner of said Lot 51; thence South 74 degrees 31 minutes 37 seconds West on the South line of said Hiron's Addition 12.51 feet to the Southeast corner of Lot 52 of Said Hiron's Addition; thence North 33 degrees 46 minutes 35 seconds West on the East line of Lots 52 through 57 of said Hiron's Addition 248.12 feet to the Point of Beginning.




