AN ORDINANCE approving CONSTRUCTION CONTRACT - OUTFALL 061 & 062 RELIEF SEWER - RESOLUTION/WORK ORDER #76087 - \$6,853,570.80 between DUNIGAN BROTHERS and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

AGREEMENT BETWEEN OWNER AND CONTRACTOR ON THE BASIS OF A STIPULATED PRICE

Resolution 76087 Work Order 76087

THIS AGREEMENT is by and between the <u>Board of Public Works of the City of Fort Wayne</u>, <u>Indiana</u> (hereinafter called Owner) and Dunigan Brothers (hereinafter called Contractor).

Owner and Contractor, in consideration of the mutual covenants hereinafter set forth, agree as follows:

ARTICLE 1 - WORK

1.01 Contractor shall complete all Work as specified or indicated in the Contract Documents. The Work is generally described as follows:

This project will include the construction of 7,025 linear feet of 36 to 72-inch combined relief sewer, a new outfall structure, floatables control, ditch restoration and 1,780 linear feet of 6 to 8-inch water main replacement. The relief sewer will collect combined sewage from CSO 061 and 062 to bring these overflows into compliance of 4 overflows events per typical year and will take these flows to the Water Pollution Control Plant's Wet Weather Ponds

ARTICLE 2 - THE PROJECT

2.01 The Project for which the Work under the Contract Documents may be the whole or only a part is generally described as follows:

Outfall 061 & 062 Relief Sewer

ARTICLE 3 – ENGINEER

3.01 The Project has been designed by Commonwealth Engineers, Inc.. Throughout these Contract Documents, the term Engineer is used. Engineer is to act as Owner's representative, assume all duties and responsibilities, and have the rights and authority assigned to Engineer in the Contract Documents in connection with the completion of the Work in accordance with the Contract Documents. Owner will advise Contractor prior to issuance of Notice to Proceed as to who will serve as Engineer.

ARTICLE 4 - CONTRACT TIMES

- 4.01 Time of the Essence
 - A. All time limits for Milestones, if any, Substantial Completion, and completion and readiness for final payment as stated in the Contract Documents are of the essence of the Contract.

4.02 Days to Achieve Substantial Completion and Final Payment

The Contractor shall complete the following activities of Work by the Milestone dates indicated. These Milestones are days after the date when the Contract Times commence to run as provided in Paragraph 2.03 of the General Conditions. Only one Project Area shall be constructed at a time with the exception of the following: 1.) Milestone 2 can be completed concurrent to Milestone 1; 2.) Baldwin Ditch Phase 1 Work can begin at any time after notice to proceed but must be completed by Milestone 5; 3) Water main installation can be completed any time during the project and this Work is not included within each Milestone.

- 1. Milestone 1: Connection to Wet Weather Ponds, White Oak and Lake Avenue Install the outfall connection to the Wet Weather Ponds and relief sewer between Stations -0+40 to 21+50. All work called out to be installed shall be completed from Station -0+40 to 21+50, with the exception of chip & seal/asphalt restoration along White Oak, concrete sidewalks, concrete streets and final seeding. Work shall be tested and approved. <u>The temporary entrance to WPCP Ponds at Beacon Street will only be allowed to be used during this milestone</u>. The work shall be completed <u>150 days</u> after the Notice-to-Proceed.
- 2. Milestone 2: Lake Avenue Restoration
 Complete the final restoration along Lake Avenue from Station 15+50 to 21+50. Work shall include final restoration of the concrete sidewalk, concrete curb, concrete street and final seeding (on the south side of Lake Avenue only). Work shall be tested and approved. The work shall be completed 180 days after the Notice-to-Proceed.
- 3. Milestone 3: Fort Wayne Clubhouse and Keller Development Install the relief sewer between Stations 21+50 to 40+30. All work called out to be installed shall be completed from Station 21+50 to 40+19. Work shall be tested and approved; dry retention basin and retaining wall shall be fully restored. Final restoration, landscaping and seeding shall be completed by May 1, 2018. The work shall be completed 300 days after the Notice-to-Proceed.
- 4. The contractor shall furnish all labor, insurance, equipment, materials and power for the completion of the project: "Outfall 061 & 062 Relief Sewer" as follows: This project will include the construction of 7,025 linear feet of 36 to 72-inch combined relief sewer, a new outfall structure, floatables control, ditch restoration and 1,780 linear feet of 6 to 8-inch water main replacement. The relief sewer will collect combined sewage from CSO 061 and 062 to bring these overflows into compliance of 4 overflows events per typical year and will take these flows to the Water Pollution Control Plant's Wet Weather Ponds.

Implications of not being approved: This work is an integral part of compliance with the Consent Decree, to reduce combined sewer overflows to the Maumee River. If not constructed, Combined Sewer Overflows will continue at a higher level into the Maumee River, thus violating our consent decree obligation and time commitment for reduction.
