Next Council Action: Ordinance will return to Council after approvals from reviewing agencies.

Synopsis of Ordinance: To vacate the northern 600 feet of right-of way of Glasgow Avenue (approximate).

Location: Beginning approximately 190 feet north of Dwenger Avenue and extending north approximately 600 feet to the south bank of the Maumee River.

Reason for Request: To allow Fort Wayne City Utilities to secure property owned by the City at the Water Pollution Control Plant.

Applicant: City of Fort Wayne

Property Owner: City of Fort Wayne

Related Petitions: none

Effect of Passage: Vacation of the northern portion of Glasgow Avenue will allow the City to install secure fencing for the Water Pollution Control property.

Effect of Non-Passage: The northern portion of Glasgow Avenue currently splits properties owned by the City. It would be difficult to secure the site with the right-of-way intact. No other properties are accessed from this area of roadway.

**AN ORDINANCE amending the Thoroughfare
Plan of the City Comprehensive ("Master")
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

A 50 foot wide strip of right-of-way in White's Fourth Addition to the City of Fort Wayne, per plat thereof, as recorded October 18, 1873 in Deed Record 60, page 476, in the Office of the Recorder of Allen County, State of Indiana, as depicted on the attached Easement Plat labeled Exhibit "B", and described as follows:

Commencing at a 5/8 inch diameter rebar with "Trav Pt GAI 0007" identification cap marking a deflection point in "Line S" and being shown as Survey Reference Point "44" on a Location Control Route Survey plat by GAI Consultants, Inc., dated 02/26/2016 and recorded as Document Number 2016012723 in the Office of the Recorder of Allen County, Indiana (said Location Control Route Survey plat being the basis of bearings for this description); thence North 29 degrees 41 minutes 04 seconds East 166.84 feet, along said "Line S"; thence North 60 degrees 18 minutes 56 seconds West 26.58 feet, to the Southernmost corner of Lot 159 in said White's Fourth Addition, being on the Northwesternly right-of-way line of Glasgow Avenue; thence North 27 degrees 09 minutes 28 seconds East 305.00 feet, along said Northwesternly right-of-way line, to the Point of Beginning; thence continuing North 27 degrees 09 minutes 27 seconds East 575.00 feet, along said Northwesternly right-of-way line, to the Southerly line of the Maumee River; thence North 86 degrees 11 minutes 38 seconds East 58.31 feet, along said Southerly line of the Maumee River, to the Southeasterly right-of-way line of said Glasgow Avenue; thence South 27 degrees 09 minutes 28 seconds West 605.00 feet, along said Southeasterly right-of-way line; thence North 62 degrees 50 minutes 32 seconds West 50.00 feet, to the Point of Beginning, containing 29,500 square feet (0.677 acres), more or less.

1 and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan
2 and is hereby approved in all respects.

3 SECTION 2. That this Ordinance shall be in full force and effect from and after its passage,

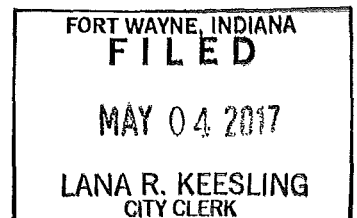

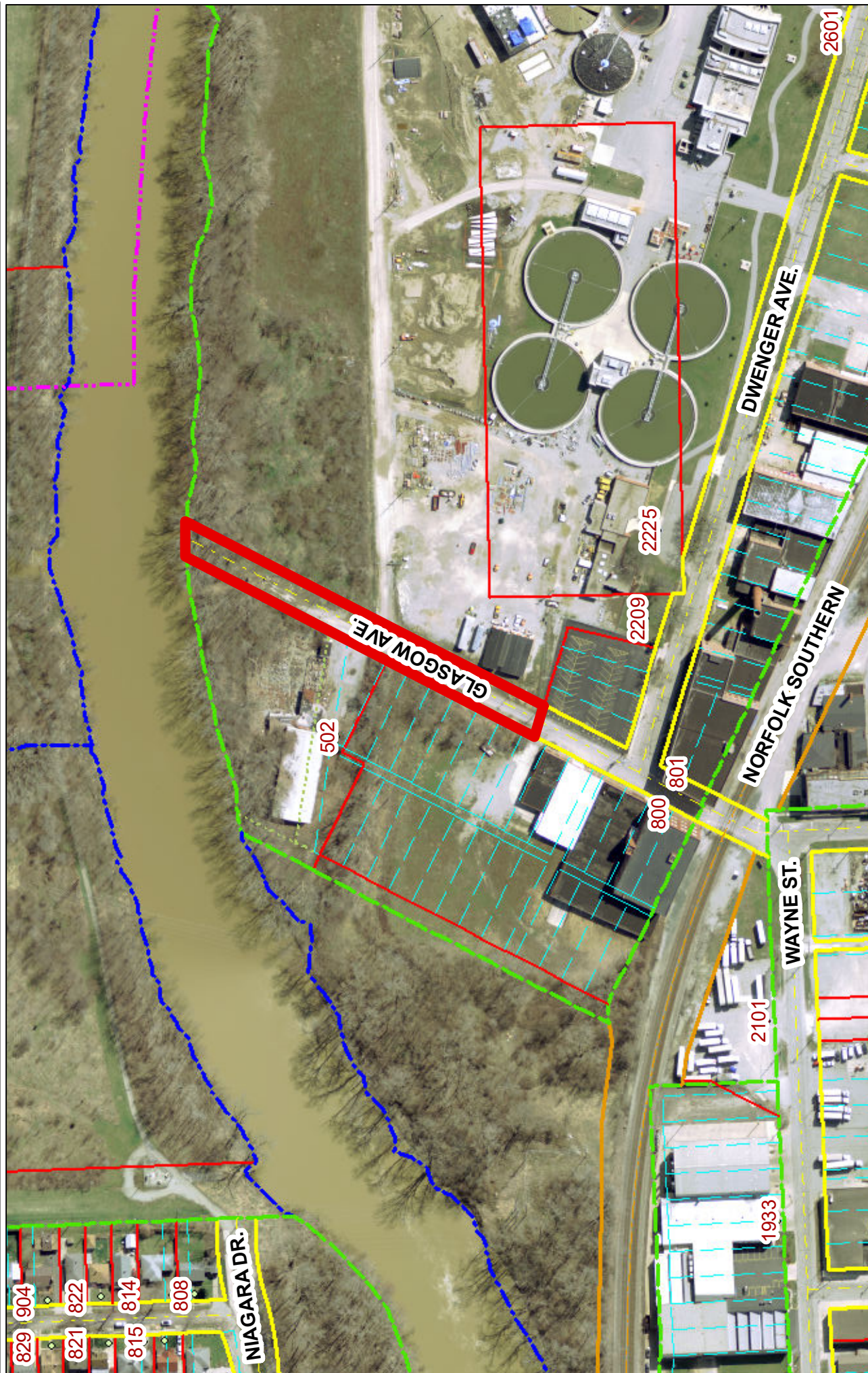
