AN ORDINANCE approving CONSTRUCTION CONTRACT - 2017 PUBLIC SIDEWALK CURB RAMP PACKAGE - RESOLUTION #0157U - WORK ORDER # 0157U - (\$309,224.00) between KEY CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT - 2017 PUBLIC SIDEWALK CURB RAMP PACKAGE - RESOLUTION #0157U - WORK ORDER # 0157U by and between KEY CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for total of 127 corner curb ramps will be reconstructed with connecting walks and ramps throughout the City. The construction will also include pavement markings and greenspace restoration;

involving a total cost of THREE HUNDRED NINE THOUSAND TWO HUNDRED TWENTY-FOUR AND 00/100 DOLLARS - (\$309,224.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.

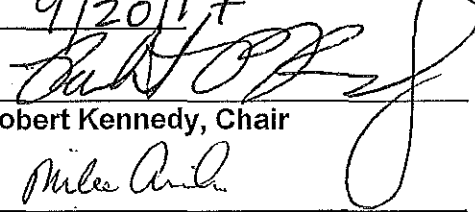

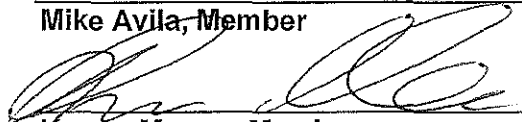

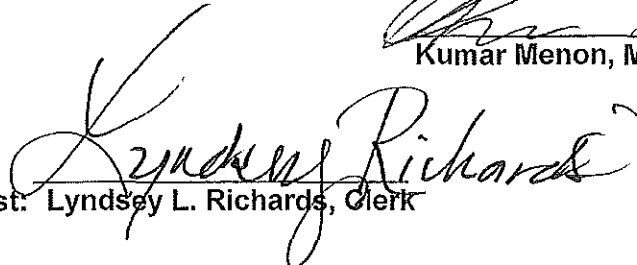
