AN ORDINANCE approving SUPPLEMENTAL 2018 SURFACE MILLING FOR STREET DEPARTMENT – RESOLUTION/WORK ORDER #0155A - \$306,241.00 between BROOKS CONSTRUCTION and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the SUPPLEMENTAL 2018 SURFACE MILLING FOR STREET DEPARTMENT – RESOLUTION/WORK ORDER #0155A between BROOKS CONSTRUCTION and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:
