ST., WINTER ST., HAYDEN ST., LILLIE ST. - RESOLUTION/WORK ORDER
#0251D by and between GARCIA CONCRETE and the City of Fort Wayne,
Indiana, in connection with the Board of Public Works, is hereby ratified, and
affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power,
transportation, miscellaneous equipment, etc., necessary for
improvement both the east-west and the north-south alley
bordered by E. Lewis St., WinterSt., Hayden St., Lillie St.,
by removal and reconstruction of the concrete alley;

involving a total cost of ONE HUNDRED SIXTY THOUSAND FIVE HUNDRED
FORTY-SIX AND 00/100 DOLLARS – (\$160,546.00). A copy of said Contract

inspection, according to law.
