TITLE OF RESOLUTION. A resolution confirming the approval of a construction contract concerning environmental remediation at 412 S. Calhoun St.

DEPARTMENT REQUESTING RESOLUTION. Department of Redevelopment.

SYNOPSIS OF RESOLUTION. Approves the Department of Redevelopment to spend up to \$354,164.00 with IWM Consulting to remediate the soil and groundwater for the Riverview, LLC development.

EFFECT OF PASSAGE. The river-adjacent-property to be developed by Riverview, LLC, a \$62.5 million development, is contaminated with hydraulic oil, gasoline and underground storage tanks. Under the guidance of the Indiana Brownfields Program, the Department of Redevelopment will work with IWM Consulting to remediate contaminated groundwater and soil necessary under the guidelines of the Indiana Department of Environmental Management. The remediation will prepare the property for safe and legal development of a downtown parking garage and river-facing apartments.

EFFECT OF NON-PASSAGE. The necessary remediation that is legally required to progress the agreements between the developer, the County and the City will not be completed. Riverview, LLC would be forced to delay or cancel construction of the proposed project.

MONEY INVOLVED (DIRECT COSTS, EXPENDITURES, SAVINGS). Expenses up to \$354,164.00 for environmental remediation will be paid with Community Development CEDIT funds already allocated by City Council as part of the annual budget process. These funds may be paid out (reimbursed) over time to the County, should the County pay these contract costs upfront (agreement pending).
