SPECIAL ORDINANCE NO. S-_____

AN ORDINANCE approving CONSTRUCTION CONTRACT - ALLEY RECONSTRUCTION - STATE BLVD., NEVADA AVE., KENTUCKY AVE., AND CRESCENT AVE. - RESOLUTION #0248D - \$350,900.00 between KEY CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT - ALLEY RECONSTRUCTION - STATE BLVD., NEVADA AVE., KENTUCKY AVE., AND CRESCENT AVE. - RESOLUTION #0248D by and between KEY CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Alley Reconstruction - spans 3 blocks and starts at State Blvd and ends at Nevada Ave between Kentucky Ave and Crescent Ave and consists of removing and replacing the existing concrete pavement including the adjacent alley approaches and spot replacement representing 1600+/- lineal feet of alley reconstruction;

involving a total cost of THREE HUNDRED FIFTY THOUSAND NINE HUNDRED AND 00/100 DOLLARS - (\$350,900.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.

Requesting an ordinance approving the Alley Reconstruction – State Blvd., Nevada Ave., Kentucky Ave., and Crescent Ave. project pursuant to the Fort Wayne Public Works resolution 0248D and an award to Key Concrete in the amount of \$350,900.00

Note: Key Concrete was the sole bidder on this project.

Description and Scope of Work:

This alley repair spans 3 blocks and starts at State Blvd and ends at Nevada Ave between Kentucky Ave and Crescent Ave and consists of removing and replacing the existing concrete pavement including the adjacent alley approaches and spot replacement of adjacent sidewalk and curb. This improvement represents roughly 1600 lineal feet of alley reconstruction.
