Requesting an ordinance approving the Brick Alley Reconstruction: Beaver Ave, Indiana Ave, West Wildwood Ave, Kinnaird Ave project pursuant to the Fort Wayne Public Works resolution 0316B and an award to Key Concrete in the amount of \$222,629.00

Note: Key Concrete was the lowest most responsible bidder among 2 bidders on the project.

Description and Scope of Work:

An east-west alley from Beaver Ave. to Indiana Ave. between Kinnaird Ave. and W. Wildwood Ave., by removing and resetting the existing brick alley, adding alley drive approaches, new castings, and seeding and restoration. This alley represents roughly 640 centerline ft of alley improvement.

This brick alley is identified as one the brick alleys in the city's brick street and alley ordinance.
