AGREEMENT BETWEEN OWNER AND CONTRACTOR ON THE BASIS OF A STIPULATED PRICE

Resolution 76480 Work Order 76480

THIS AGREEMENT is by and between the <u>Board of Public Works of the City of Fort Wayne</u>, <u>Indiana</u> (hereinafter called Owner) and F. A. Wilhelm <u>Construction Co.</u>, <u>Inc.</u> (hereinafter called Contractor).

Owner and Contractor, in consideration of the mutual covenants hereinafter set forth, agree as follows:

ARTICLE 1 - WORK

1.01 Contractor shall complete all Work as specified or indicated in the Contract Documents. The Work is generally described as follows:

Rudisill Consolidation Sewer includes the construction of a diversion structure, screen and gate structure, relocation of various existing utilities and related appurtenances. This project is to connect Combined Sewer Outfalls 18 and 19 to the 3RPORT tunnel system at Drop Shaft 01. The Work includes, but is not limited to, the following: a 30 foot by 34 foot diversion structure, approximately 60 feet of 84 inch by 84 inch consolidation sewer, a 27 foot by 37 foot screen and gate structure, 120 inch by 120 inch flap gate replacement, existing sewer and watermain relocation, and associated site restoration.

ARTICLE 2 - THE PROJECT

2.01 The Project for which the Work under the Contract Documents may be the whole or only a part is generally described as follows:

ARTICLE 3 - ENGINEER

- 3.01 The Project has been designed by Black and Veatch Corporation, VS Engineering Inc., and DLZ Inc.. Throughout these Contract Documents, the term Engineer is used. ARTICLE 4 - CONTRACT TIMES

4.01 Time of the Essence

A. All time limits for Milestones, if any, Substantial Completion, and completion and readiness for final payment as stated in the Contract Documents are of the essence of the Contract.

4.02 Days to Achieve Substantial Completion and Final Payment

- A. The Work will be substantially completed within 485 days after the date when the Contract Times commence to run as provided in Paragraph 2.03 of the General Conditions, and completed and ready for final payment in accordance with Paragraph 14.07 of the General Conditions within 545 days after the date when the Contract Times commence to run.
- B. Definitions of Substantial Completion for this Work shall consist of all work within the Contract Documents is complete including but not limited to, the consolidation sewer, diversion structure, screen and gate structure, flap gate replacement, underground utility piping, site fencing, and paving and utility relocation are completed to the satisfaction of the Engineer. Final grading and seeding is the only item to be completed after the Work is accepted as Substantially Complete.

4.03 Liquidated Damages

that may become due and moneys that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.

10.03 Successors and Assigns

A. Owner and Contractor each binds itself, its partners, successors, assigns, and legal representatives to the other party hereto, its partners, successors, assigns, and legal representatives in respect to all covenants, agreements, and obligations contained in the Contract Documents.

10.04 Severability

A. Any provision or part of the Contract Documents held to be void or unenforceable under any Law or Regulation shall be deemed stricken, and all remaining provisions shall continue to be valid and binding upon Owner and Contractor, who agree that the Contract Documents shall be reformed to replace such stricken provision or part thereof with a valid and enforceable provision that comes as close as possible to expressing the intention of the stricken provision.

10.05 Contractor's Certifications

- A. Contractor certifies that it has not engaged in corrupt, fraudulent, collusive, or coercive practices in competing for or in executing the Contract. For the purposes of this Paragraph 10.05:
 - 1. "corrupt practice" means the offering, giving, receiving, or soliciting of anything of value likely to influence the action of a public official in the bidding process or in the Contract execution;
 - 2. "fraudulent practice" means an intentional misrepresentation of facts made (a) to influence the bidding process or the execution of the Contract to detriment of Owner, (b) to establish Bid or Contract prices at artificial non-competitive levels, or (c) to deprive Owner of the benefits of free and open competition;
 - 3. "collusive practice" means a scheme or arrangement between two or more Bidders, with or without the knowledge of Owner, a purpose of which is to establish Bid prices at artificial, non-competitive levels; and
 - 4. "coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the bidding process or affect the execution of the contract.

10.06 M.B.E./W.B.E. Participation

A. Indiana State Revolving Fund Loan Program — This project is being financed in whole or in part by the Indiana State Revolving Fund Loan Programs. - C. <u>Determination of Waiver Requests</u> The Vendor Compliance Department of the City of Fort Wayne shall examine all Requests for Waiver to determine if Contractor's efforts constitute good faith efforts to attain such goal and shall submit recommendations concerning said requests for Waiver for the final determination of the Board of Public Works of the City of Fort Wayne.

The contractor shall furnish all labor, insurance, equipment, materials and power for the completion of the project: Rudisill Consolidation Sewer and Extension to Foster Park Relief Sewer Connection as follows: Rudisill Consolidation Sewer includes the construction of a diversion structure, screen and gate structure, relocation of various existing utilities and related appurtenances. This project is to connect Combined Sewer Outfalls 18 and 19 to the 3RPORT tunnel system at Drop Shaft 01. The Work includes, but is not limited to, the following: a 30 foot by 34 foot diversion structure, approximately 60 feet of 84 inch by 84 inch consolidation sewer, a 27 foot by 37 foot screen and gate structure, 120 inch by 120 inch flap gate replacement, existing sewer and watermain relocation, and associated site restoration.

<u>Implications of not being approved:</u> This project is one part of compliance with the Consent Decree to reduce combined sewer overflow to the St Mary's River.
