ZONING MAP ORDINANCE NO. Z-____

AN ORDINANCE amending the City of Fort Wayne Zoning Map No. N-66 (Sec. 33 of Perry Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the area described as follows is hereby designated a C1 (Professional Office and Personal Services) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

Five acres of land in the Southeast Quarter of the Northeast Quarter of Section 33, Township 32 North, Range 12 East, Allen County, Indiana, being more particularly described as follows:

COMMENCING at a point in the East line of the Southeast Quarter of the Northeast Quarter of said Section 33, said point being 327.1 feet North of the East Quarter corner of said Section 33; thence West and parallel with the South line of the Southeast Quarter of the Northeast Quarter of said Section 33, a distance of 664.5 feet; thence North a distance of 327.76 feet; thence East a distance of 664.5 feet to the East line of the Southeast Quarter of the Northeast Quarter of said Section 33; thence South along the East line of the Southeast Quarter of the Northeast Quarter of said Section 33, a distance of 327.76 feet to the place of beginning, containing 5 acres of land, more or less.

EXCEPT:

Part of Section 33, Township 32 North, Range 12 East, Allen County, Indiana, more particularly described as follows, to-wit:

COMMENCING at a point on the East line of the Southeast Quarter of the Northeast Quarter of said Section 33, said point being 327.1 feet North of the East Quarter corner of said Section 33; thence West and parallel with the South line of the Southeast Quarter of the Northeast Quarter of said Section 33, a distance of 664.5 feet; thence North a distance of 163.88 feet; thence East a distance of 664.5 feet to the East line of the Southeast Quarter of the Northeast Quarter of said Section 33; thence South along the East line of the Southeast Quarter of the Northeast Quarter of said Section 33, a distance of 163.88 feet to the point of beginning, containing 2 1/2 acres of land, more or less.

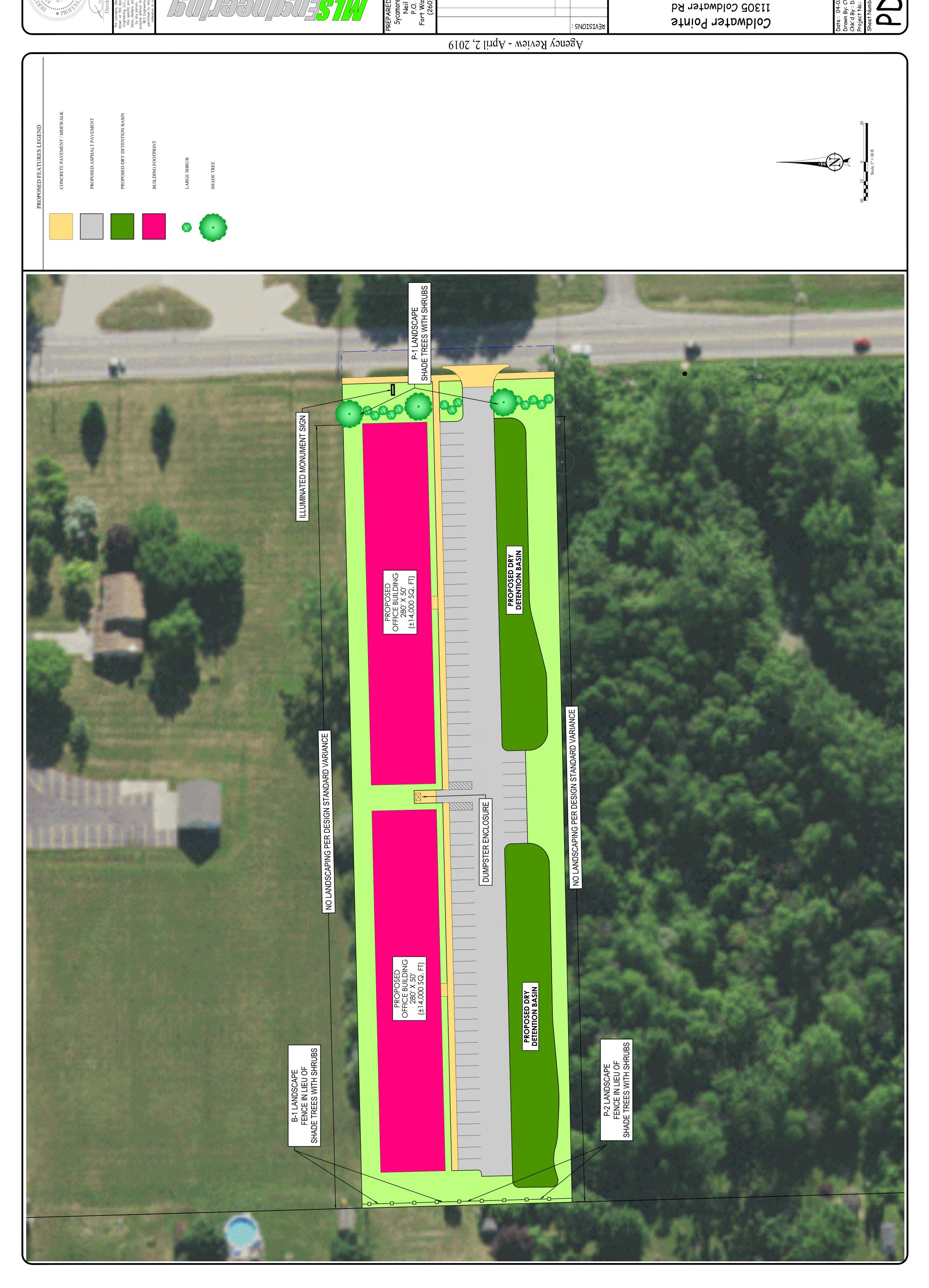
