Synopsis of Ordinance: To vacate public right-of-way on the Electric Works campus.

Location: Caroline Street, south of Lots 14 through 22 in Jones Addition, Nelson Street between Lots 16 and 17 in Jones Addition, and the 15 foot wide alley west of Lot 15 in Jones Addition; all north of the CSX Railroad and south of the 1200 to 1300 blocks of Jones Street.

Reason for Request: The applicant requires the vacation to redevelop the Electric Works campus.

Applicant: Broadway Redevelopment Partners, LLC

Property Owner: Broadway Redevelopment Partners, LLC

Related Petitions: VROW-2019-0003, 0005, 0006, 0007, and 0008

Effect of Passage: Vacation of the right-of-way will return the land to the adjacent property owner and allow for redevelopment of the Electric Works campus.

Effect of Non-Passage: The right-of-way will remain under City jurisdiction. Redevelopment of the Electric Works campus, as approved by the City of Fort Wayne Plan Commission, will have to be substantially altered.

**AN ORDINANCE amending the Thoroughfare
Plan of the City Comprehensive ("Master")
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

The entirety of Caroline Street, lying south of and adjacent to Lots 14 through 22 in Jones' Addition to the City of Fort Wayne, according to the plat thereof, recorded in Deed Book X, page 502 in the Office of the Recorder of Allen County, Indiana.

That part of Nelson Street lying between Lot 16 and Lot 17 in Jones' Addition to the City of Fort Wayne, according to the plat thereof, recorded in Deed Book X, page 502 in the Office of the Recorder of Allen County, Indiana.

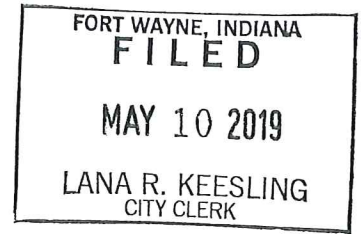

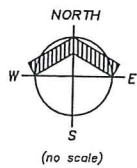
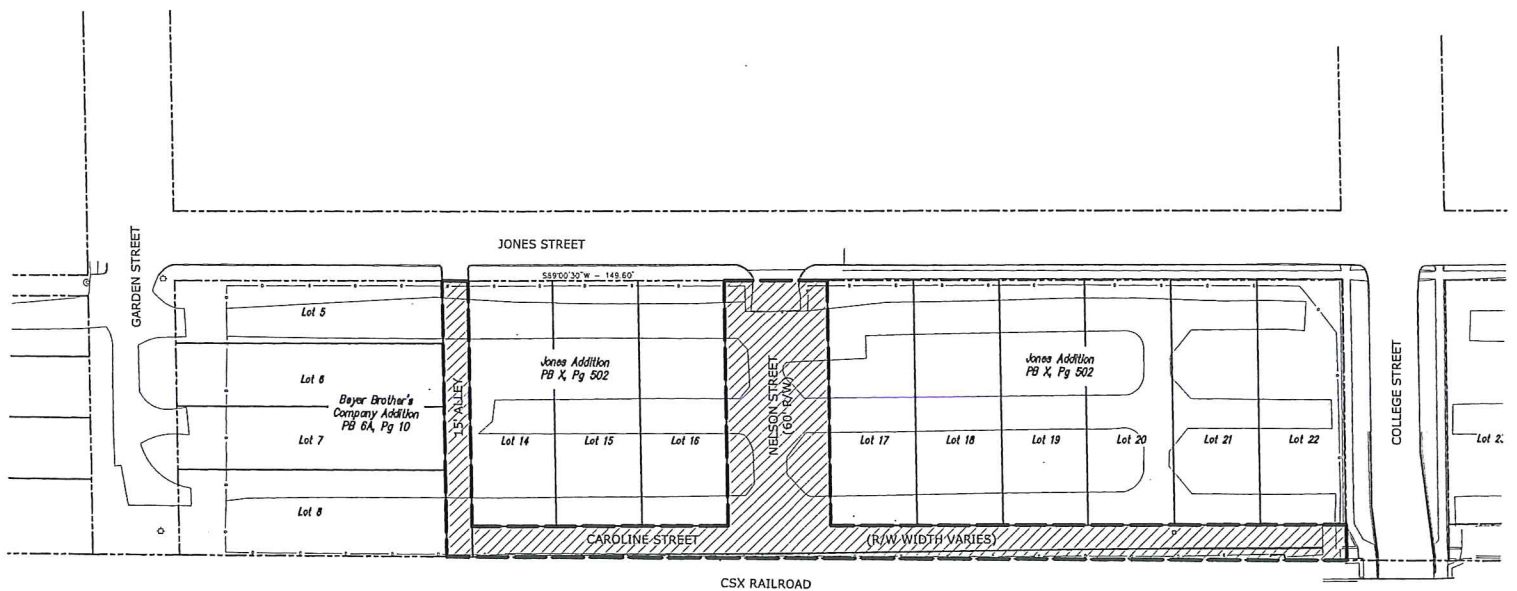
