Synopsis of Ordinance: To vacate public right-of-way on the Electric Works campus.

Location: The 14 foot wide alley east of Lots 6 and 7 of Chipman's Addition, the 12 foot wide alley south of Lots 11 and 12 of Chipman's Addition, and the 10 foot wide alley south of Lot 14 of Chipman's Addition; all west of the 1400 block of Jackson Street, and east of 1420 and 1430 Broadway.

Reason for Request: The applicant requires the vacation to redevelop the Electric Works campus.

Applicant: Broadway Redevelopment Partners, LLC

Property Owner: Broadway Redevelopment Partners, LLC

Related Petitions: VROW-2019-0003, 0004, 0005, 0006, and 0008

Effect of Passage: Vacation of the right-of-way will return the land to the adjacent property owner and allow for redevelopment of the Electric Works campus.

Effect of Non-Passage: The right-of-way will remain under City jurisdiction. Redevelopment of the Electric Works campus, as approved by the City of Fort Wayne Plan Commission, will have to be substantially altered.

**AN ORDINANCE amending the Thoroughfare
Plan of the City Comprehensive ("Master")
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

The 14 feet wide platted alley lying east of and adjacent to Lot 6 and Lot 7 in Chipman's Addition to the City of Fort Wayne, according to the plat thereof, recorded in Deed Book N, page 475 in the Office of the Recorder of Allen County, Indiana.

The 12 feet wide alley over the south 12 feet of Lot 11 and Lot 12 in Chipman's Addition to the City of Fort Wayne, according to the plat thereof, recorded in Deed Book N, page 475 in the Office of the Recorder of Allen County, Indiana.

The 10 feet wide platted alley, not previously vacated, lying between Lot 4 and Lot 14 in Chipman's Addition to the City of Fort Wayne, according to the plat thereof, recorded in Deed Book N, page 475 in the Office of the Recorder of Allen County, Indiana.

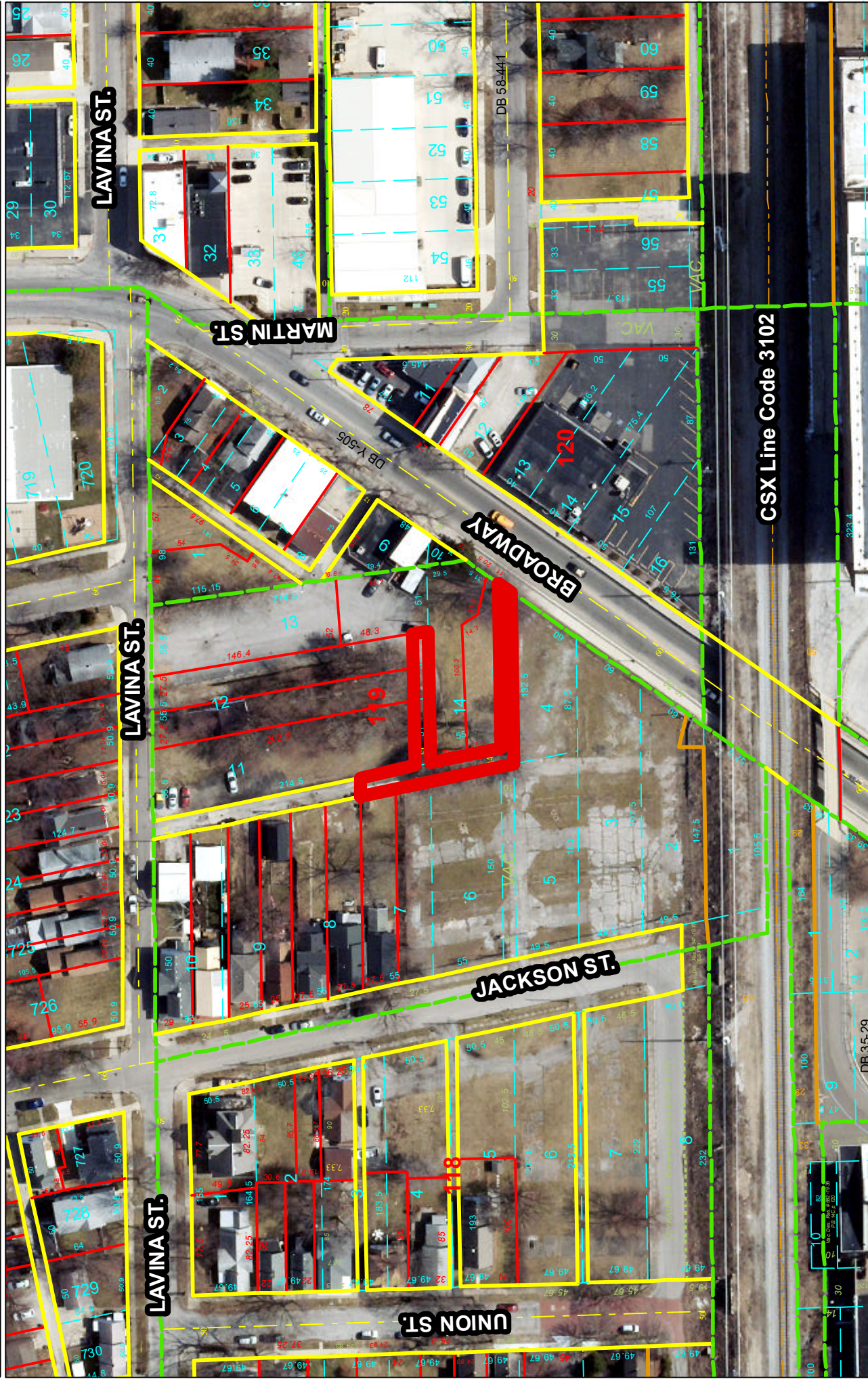
and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan and is hereby approved in all respects.

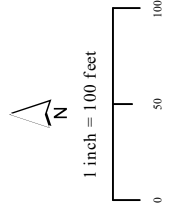

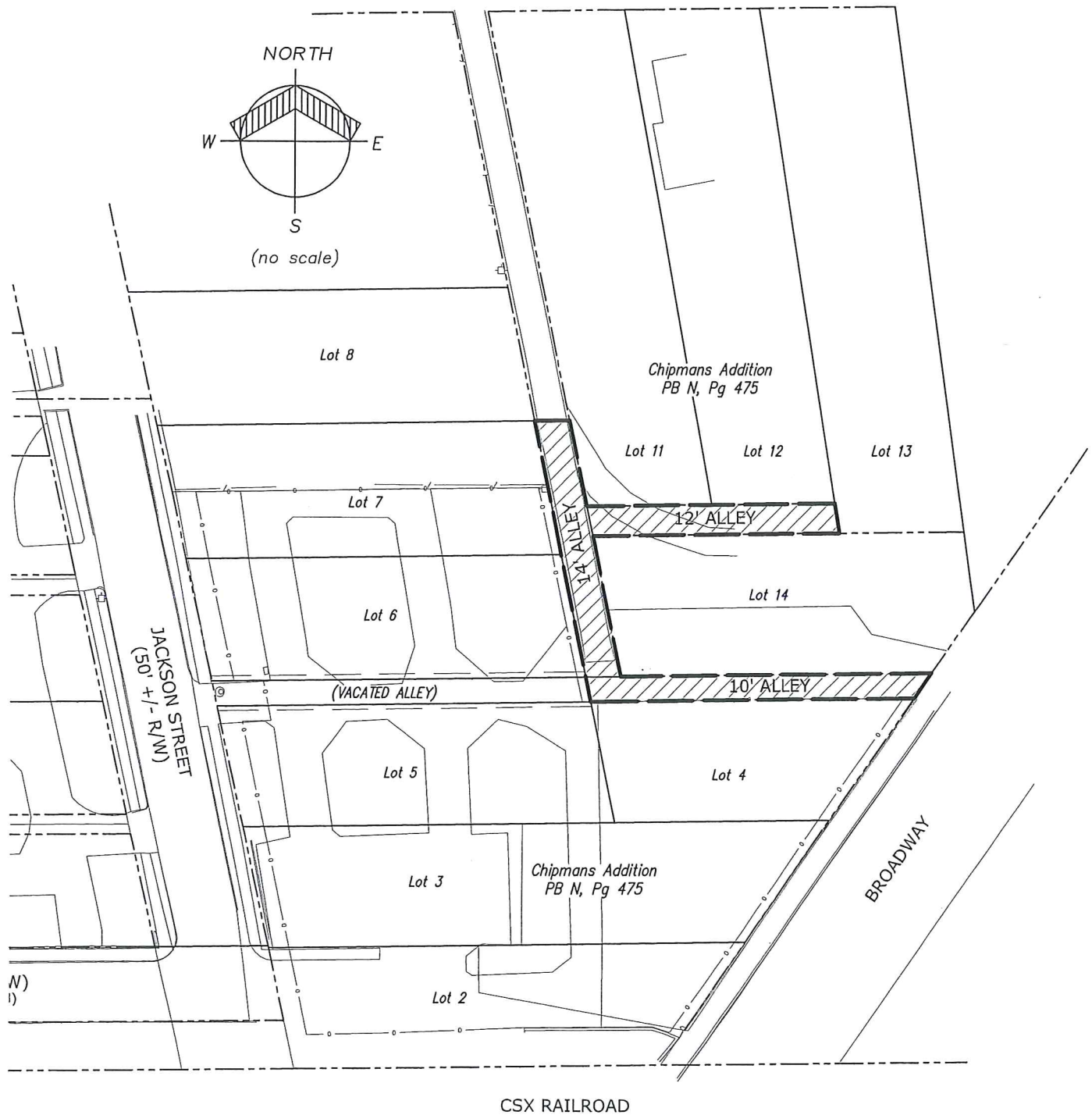
