Synopsis of Ordinance: To vacate public right-of-way on the Electric Works campus.

Location: The 12 foot wide alley north of Lots 23 through 26 in Swinney's Addition to Fort Wayne. North of 1120 Swinney Avenue

Reason for Request: The applicant requires the vacation to redevelop the Electric Works campus.

Applicant: Broadway Redevelopment Partners, LLC

Property Owner: Broadway Redevelopment Partners, LLC

Related Petitions: VROW-2019-0004, 0005, 0006, 0007, and 0008

Effect of Passage: Vacation of the right-of-way will return the land to the adjacent property owner and allow for redevelopment of the Electric Works campus.

Effect of Non-Passage: The right-of-way will remain under City jurisdiction. Redevelopment of the Electric Works campus, as approved by the City of Fort Wayne Plan Commission, will have to be substantially altered.

**AN ORDINANCE amending the Thoroughfare
Plan of the City Comprehensive ("Master")
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

The 12 feet wide platted alley lying north of and adjacent to Lots 23 through 26 in Swinney's Addition to Fort Wayne Ind., according to the plat thereof, recorded in Deed Book 95, page 332 in the Office of the Recorder of Allen County, Indiana.

and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan and is hereby approved in all respects.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage, any and all necessary approval by the Mayor.

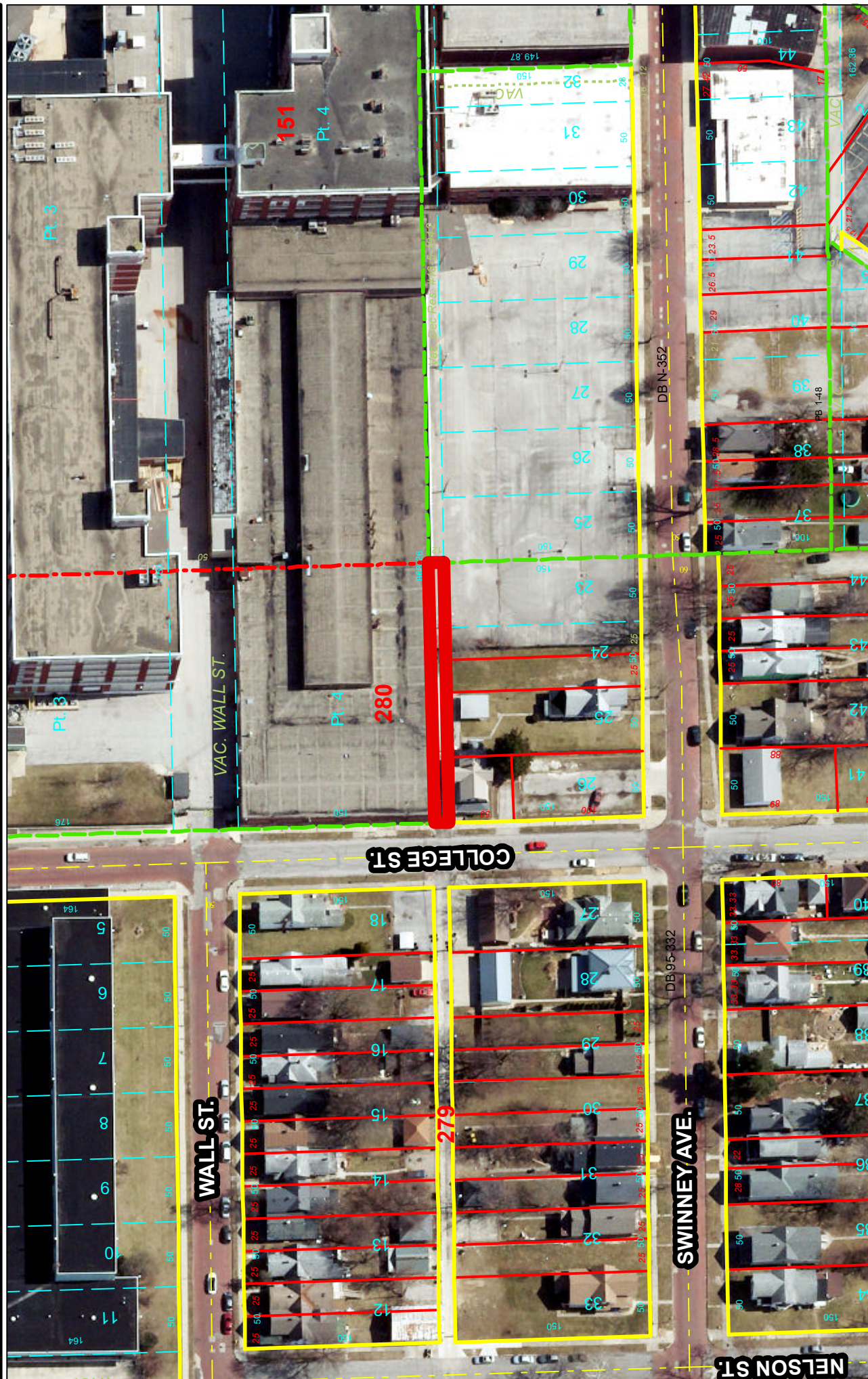

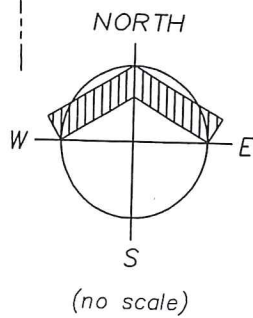
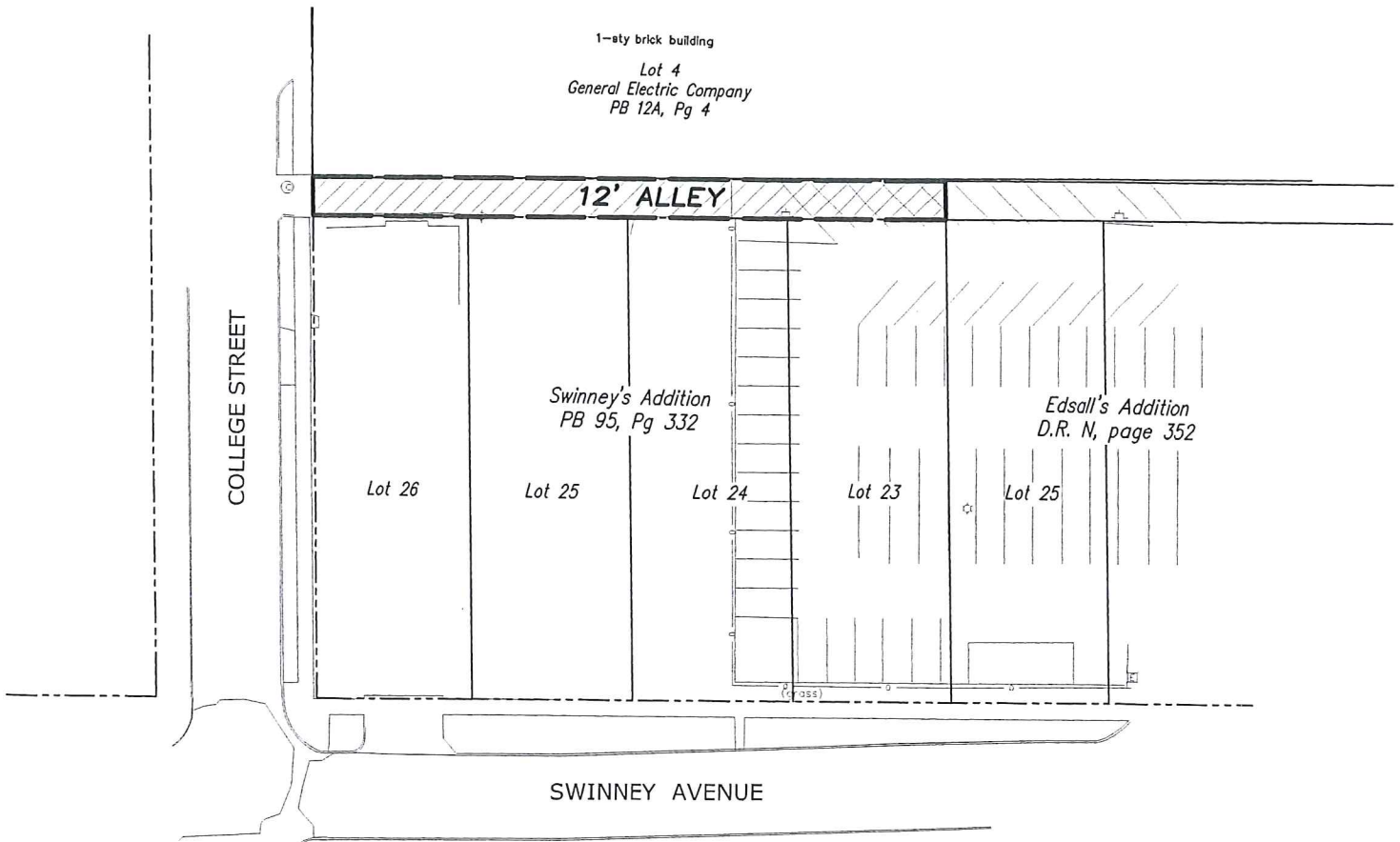
