ZONING MAP ORDINANCE NO. Z-____

AN ORDINANCE amending the City of Fort Wayne Zoning Map No. L-27 (Sec. 26 of Wayne Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the area described as follows is hereby designated a C3 (General Commercial) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

Part of Lot #7 in Godfrey's Partition of Out Lots made by W. H. Goshorn and J. S. Goshorn, Commissioners of Allen Circuit Court as shown in Order Book #22, pages 112 and 142 of said County, being a subdivision of Lots #3, 4 and 7 and 14.25 acres off of the Northeasterly side of Lot #2 in the subdivision of Richardville Reserve, west of the Saint Mary's River in Township 30 North, Range 12 East, made by Lewis Newberger, Commissioner, as recorded in Order Book "T" page 263 in the Allen Circuit Court more particularly described as follows, to-wit:


Commencing at the Southeast corner of the said Lot #7; thence North 20 degrees 50 minutes West on and along the centerline of Winchester Road 232.0 feet to a point; thence North 32 degrees 05 minutes West on and along the aforesaid centerline 125.1 feet to the point of beginning of the herein described real estate; thence continuing North 32 degrees 05 minutes West on the aforesaid centerline 152.98 feet to a point; thence South 84 degrees 10 minutes West 156.81 feet to a point; thence South 32 degrees 05 minutes East on and along a line parallel to the centerline of said road 80 feet to a point; thence South 76 degrees 44 minutes East 200 feet to the point of beginning of this description, containing 0.38 acres of land more or less and subject to road rights of way and easements.
