ADDENDUM

TO THE

INTERLOCAL AGREEMENT

BETWEEN

THE BOARD OF COMMISSIONERS OF THE COUNTY OF ALLEN, INDIANA

AND

THE CITY OF FORT WAYNE, INDIANA

CONCERNING

DIEBOLD ROAD IMPROVEMENTS

THIS ADDENDUM, is made and entered into this <u>9</u> day of <u>July</u> 2019, by and between the Board of Commissioners of the County of Allen, Indiana ("COUNTY"), the City of Fort Wayne, Indiana, by and through its Board of Public Works ("CITY"), and the Allen County Redevelopment Commission ("COMMISSION").

RECITALS:

WHEREAS, the COUNTY, the CITY, and the COMMISSION have entered into an Interlocal Agreement dated December 19, 2014, to jointly finance, develop, and construct improvements to Diebold Road from North Clinton Street to East Dupont Road ("PROJECT"); and

WHEREAS, the COMMISSION has created the Dupont Corner economic development area (the "Dupont Center EDA") for the purpose of funding the project through periodic payments through a tax incremental funding designation; and

WHEREAS, the COMMISSION has also created the Dupont Diebold Economic Development Area (the "Dupont Diebold EDA") for the purpose of assisting in the funding of the Project among other purposes; and

WHEREAS, realignment of the south section of Diebold Road and reconfiguration of its intersection with North Clinton has been proposed; and

WHEREAS, the parties are desirous to carry forward the proposed realignment and intersection, and so, to amend in part the project scope and budget necessary for plan development, right-of-way acquisition, and construction toward that end; NOW, THEREFORE, in consideration of the foregoing Recitals and the mutual promises and covenants set forth in the Interlocal Agreement, the Parties hereto agree that:

- 1. The table of "Estimated Project Costs" in Section 4 of the Interlocal Agreement shall be replaced with the updated table in Exhibit "A", entitled "Estimated Project Costs & Proposed Funding Split"; and
- 2. Section 9(b) shall be amended to read as follows:

The City and the County will be reimbursed for all costs for the Project paid by each hereunder with revenues generated by the Dupont Center EDA and the Dupont Diebold EDA. Such reimbursement payments shall be made on a pro rata basis to the City and the County on an annual basis from first available TIF Revenues from the Dupont Center EDA and available revenues from the Dupont Diebold EDA until the City and the County have been fully reimbursed for all funds paid by the City and the County hereunder. The use of the TIF Revenues from the Dupont Center EDA for any other purpose prior to the reimbursement in full of the City and the County shall require unanimous approval of the Board of Works of the City of Fort Wayne and the Board of Commissioners of the County of Allen, Indiana.
