7	WHEREAS, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution property at 7601 South Anthony for Live Wire-Fort Wayne, LLC (Confirming Resolution R-34-16) under Sections 153.13-153.24 of the Municipal Code of the	
8	City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and	
9	WHEREAS, the original Statement of Benefits and economic revitalization area designation application submitted by Live Wire-Fort Wayne, LLC and approved under Confirming Resolution R-34-16 was for a vacant building deduction and \$9,000,000 in real property	
10	improvements; and WHEREAS, representatives of Live Wire-Fort Wayne, LLC have informed the City of Fort	
11	Wayne that their Statement of Benefits Real Estate Improvements (Form CF-1/Real Property) for 2019 was not filed in a timely manner; and	
12	WHEREAS, this oversight was an unusual occurrence for Live Wire-Fort Wayne, LLC; and	
13	WHEREAS, the Common Council finds that Live Wire-Fort Wayne, LLC has completed its pledge to construct the real property improvements; and	
14	WHEREAS, the Common Council acknowledges that Live Wire-Fort Wayne, LLC has requested a waiver of noncompliance which the Common Council has the power and authority to	
15	approve, under I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3; and WHEREAS, the Common Council intends that Live Wire-Fort Wayne, LLC receive the	
16	tax abatement benefits to which they would have been entitled had no non-compliance event occurred, so long as the waiver of non-compliance and the granting of those benefits does not	
17	prejudice the City of Fort Wayne; and WHEREAS, the Common Council has concluded that granting of the ERA deduction for	
18	2019 payable 2020 tax year would not create a strain on the City of Fort Wayne's fiscal budget; and	
19	WHEREAS, I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3 permit tax abatement noncompliance events such as the untimely filing of statement of benefits (CF-1) paperwork to be	
20	waived; and WHEREAS, the non-compliance event has been corrected and a public hearing of the Common Council has been held on the waiver.

22	NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:	
23	<b>SECTION 1.</b> That, Common Council hereby waives all clerical and technical errors and nonconformities that are waiveable under State and local law, including without limitation those	
24	errors and nonconformities described in I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3.	
25	<b>SECTION 2.</b> As authorized by I.C. 6-1.1-12.1-9.5(d), the Common Council will permit Live Wire- Fort Wayne, LLC to receive the real property economic revitalization area deductions for 2019	
26	payable 2020 under Confirming Resolution R-34-16. The Allen County Auditor shall be supplied with a copy of this Resolution, upon passage, and instructed to apply the deduction amounts in	
27	accordance with this schedule. This resolution shall have no effect on the assessed value, tax abatement deductions or taxes payable with respect to Live Wire-Fort Wayne, LLC's personal	
28	property.
