ZONING MAP ORDINANCE NO. Z-___

AN ORDINANCE amending the City of Fort Wayne Zoning Map No. D-07 (Sec. 18 of Wayne Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE,

SECTION 1. That the area described as follows is hereby designated an RP (Planned Residential) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

The North 291 feet of the East 208 feet of Lot Number 1 in Rousseau's Third Garden Addition to the City of Fort Wayne, Allen County, Indiana, according to the plat thereof, recorded in Plat Record 6, Page 65, in the Office of the Recorder of Allen County, Indiana, excepting the South 95.5 feet of said North 291 feet and except the East 25 feet thereof appropriated for the opening of Getz Road, reference being had to Commissioners Record 7 Page 241, in the Office of the Auditor of Allen County, Indiana. Also known as the North 195.5 feet of the East 208 feet except the East 25 feet, of Lot Number 1 in Rousseau's Third Addition, as recorded in the plat thereof in the Office of the Recorder of Allen County,

and the symbols of the City of Fort Wayne Zoning Map No. D-07 (Sec. 18 of Wayne Township), as established by Section 157.082 of Title XV of the Code of the City of Fort Wayne, Indiana is hereby changed accordingly.

SECTION 2. If a written commitment is a condition of the Plan Commission's recommendation for the adoption of the rezoning, or if a written commitment is modified and approved by the Common Council as part of the zone map amendment, that written commitment is hereby approved and is hereby incorporated by reference.




