WHEREAS, April 1, 2020 is the official Census Day for individuals to submit their Census form online, by phone, or by mail; and

WHEREAS, the City of Fort Wayne officially kicked off the 2020 Census Complete Count Committee on October 18, 2019, and all City of Fort Wayne and Allen County residents are invited to participate in the Fort Wayne Counts On Me awareness campaign; and

WHEREAS, the information collected by the Census is confidential and protected by law; and

WHEREAS, under Title 13, the Census Bureau cannot release any identifiable information about individual information collected in the census, even to law enforcement agencies, and private data is protected; and

WHEREAS, Fort Wayne's Complete Count Committee (CCC) is comprised of a united voice from business, government, community-based and faith-based organizations, educators, and media outlets to enable the 2020 Census message to reach all citizens; and

WHEREAS, the purpose of the CCC is to raise awareness of the importance of Census 2020, strategically reaching out to historically undercounted communities, and to encourage collaborating community advocates to vigorously participate in sharing information about the Census with all members of the community; and

WHEREAS, a complete count ensures accurate Census data that is critical for local governmental policies and decision making, including, but not limited to the funding of programs related to housing, schools, health, infrastructure, and emergency services that critically impact the community; and

WHEREAS the American Community Survey as it is a vital tool for economic development and employment projections; and

WHEREAS, future federal representation is determined by a complete count, ensuring that Northeast Indiana remains appropriately represented on the national level; and
