A RESOLUTION OF THE

COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA,
CONFIRMING AND RATIFYING THE DISTRIBUTION OF AVAILABLE
FUNDS FROM THE CITY OF FORT WAYNE COMMUNITY LEGACY FUND
TO THE FORT WAYNE REDEVELOPMENT COMMISSION
WITH REGARD TO AN ECONOMIC DEVELOPMENT PROJECT
TO BE UNDERTAKEN BY RTM VENTURES LLC AND ITS AFFILIATES

WHEREAS, the Fort Wayne Redevelopment Commission (the "Commission"), governing body of the City of Fort Wayne, Indiana, Department of Redevelopment (the "Department") and the Redevelopment District of the City of Fort Wayne, Indiana, exists and operates under the provisions of the Redevelopment of Cities and Towns Act of 1953, which has been codified in Indiana Code 36-7-14 et seq., as amended from time to time (the "Act"); and

WHEREAS, the Commission has previously designated and declared in accordance with the Act an area in the City of Fort Wayne, Indiana (the "City"), known as the Broadway-Taylor Redevelopment Project Area, to be a redevelopment area and an allocation area (the "Area"), adopted a redevelopment plan, and established an allocation fund for said Area; and

WHEREAS, RTM Ventures LLC, a Delaware limited liability company, and its affiliates, Broadway Redevelopment Partners, LLC, EW West Campus Landlord, LLC and EW East Campus, LLC (the "Developer"), have proposed the construction, rehabilitation, repair and redevelopment, including office, residential and retail uses, as more particularly described on Exhibit A attached hereto (the "Project"), on a parcel of Real Estate located generally south of the CSX railroad tracks, west of Broadway

Avenue and north of Swinney Avenue in Fort Wayne, Indiana, legally described on Exhibit B attached hereto (the "Project Real Estate"); and

WHEREAS, Developer programmed a public market as part of the Electric Works West Campus development and agrees to establish a non-profit Public Market Trust for the purpose of supporting the market and promoting various community needs; and

WHEREAS, on September 10, 2018, the Commission entered into an Economic Development Agreement with Developer which was terminated by the Commission on August 3, 2020; and

WHEREAS, on October 12, 2020, the Commission entered into a new Economic Development Agreement with Developer ("2020 EDA") in order to stimulate and induce the Project; and

WHEREAS, the Commission has determined that the completion of the Project is in the best interests of the citizens and taxpayers of the City and, to stimulate and induce the completion of the development of the Project, the Commission agreed in the 2020 EDA, subject to further proceedings as required by law, to provide certain economic development incentives in exchange for the development of the Project; and

WHEREAS, the City of Fort Wayne has established the City of Fort Wayne Community Legacy Fund ("Legacy Fund") to invest in projects that will have a collective impact that leads to transformational change within the community; and

WHEREAS, the Fort Wayne Legacy Joint Funding Committee has found that the Project will have a collective impact that leads to transformational change within the City and determined that the Project is worthy of investment from the Legacy Fund; and

WHEREAS, the Commission has requested the distribution of available funds from the Legacy Fund in the amount of Ten Million and No/100 Dollars (\$10,000,000.00) to be used in the provision of economic development incentives to the Project as provided in the 2020 EDA ("Legacy Pledge"); and

WHEREAS, the Common Council has previously determined and hereby confirms and ratifies that the completion of the Project is in the best interests of the citizens and taxpayers of the City and desires to provide for the stimulation and inducement of the Project through the pledge of available funds from the Legacy Fund, as provided in this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA, AS FOLLOWS:

The Common Council finds, determines, ratifies and confirms that the Project (a) will have a collective impact that leads to transformational change in the community and is worthy of investment from the Legacy Fund; and (b) is in the best interests of the citizens and taxpayers of the City of Fort Wayne and will support the redevelopment goals of the City of Fort Wayne in the Area.

The Common Council does hereby confirm and ratify its appropriation and pledge to the Commission the amount of Ten Million and No/100 Dollars (\$10,000,000.00) to be used by the Commission to provide economic development incentives to the Project, to be paid to the Commission no later than five (5) days prior to the Fund Closing, as defined in and pursuant to the 2020 EDA.

The Common Council does hereby authorize the Board of Trustees of the City of Fort Wayne Community Trust Fund to make the distribution set forth in Section 2 above.

EXHIBIT A

Description of Project

The renovation and new construction of Buildings 19, 20, 21, 22, 22(a), 23, 23(a), 24, 25, 25(a), 26, 26(c), 27, 27(a), 31, 36 and F, all as part of the Development Plan of Electric Works West Campus, a mixed-use development that will be an 18-hour Campus allowing the public to live, work, and play in buildings that will preserve the history of the site and that will be repurposed to revitalize space for offices, residences, education, health care, entertainment, retail, and innovation and entrepreneurship.

The project will be located in the former General Electric Campus, south of the CSX railroad tracks, west of Broadway, and north of Swinney Avenue.
