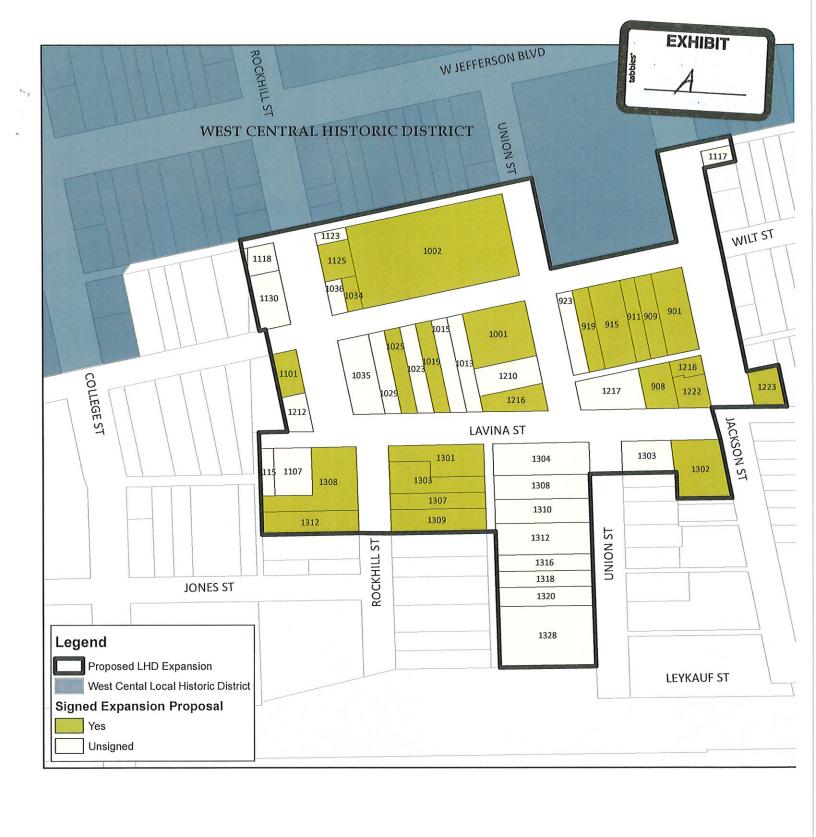

STAFF REVIEW OF HISTORIC DISTRICT APPLICATION

Applicant: West Central Neighborhood Association

Case No.: HPC 9-28-20-LHD-1

Historic Name: West Central Historic District Expansion 2020

Description:

A portion of the area served by the West Central Neighborhood Association, adjacent to and south of the existing West Central local historic district. The proposed historic district expansion consists of an area roughly defined by Wilt Street, Jackson Street, Lavina Street, and Rockhill Street; and parcels on the west side of the 1300 block of Union Street.

Date of Review: September 28, 2020

Interim Report Information:

In the 1996 Interim Report of the Indiana Sites and Structures Inventory for Fort Wayne, this area of the West Central Neighborhood was surveyed as an update of the information for the previously National Register-listed West End Historic District (1984). A windshield survey follow-up of the Interim Report occurred about 8 years ago, and the area was confirmed to remain a contributing area of the West End Historic District. In the final phase of the Allen County-Fort Wayne Historic Resources Inventory, in 2019, the district and its individual buildings were reevaluated. A high percentage of the houses and structures in the proposed expansion area continue to have "Contributing" ratings.

Reason for Application and Process:

The West Central Community Development Area Plan (CDAP) was completed in 2004. Within the "Topic Area" of Historic Preservation the plan made several recommendations. The first Goal is to, "Enhance the residential quality of the neighborhood and promote economic development through the preservation, rehabilitation, restoration, and recognition of the neighborhood's historic resources, as well as the education of neighborhood residents and the community at large." Further, under Policy C, the neighborhood association adopted the policy to, "Expand local historic district boundaries."

The West Central Neighborhood Association (WCNA) is dedicated to using local historic designation as a tool to improve the quality and environment of the WCNA. The association has seen that local historic designation is a very effective strategy for stabilizing neighborhoods and increasing property values.

The association began the current LHD petition process to pursue expansion of the existing local historic district in October of 2019. The WCNA formed a local historic designation committee that first met on November 4, 2019 to discuss the potential boundary; it was decided to choose a smaller boundary than previous efforts to expand the local historic district in recent years. The map for the proposed expansion in 2018 was scaled back for the current effort. Subsequently the WCNA Board of Directors voted unanimously on November 11 to pursue a petition process to expand the district. (Note: areas of the National Register-listed district that do not currently have local historic designation, and that do not fall within this petition area, may be part of future petition efforts.)

This petition effort was led by Tyler Bowers, a WCNA board member. The effort for outreach to the property owners began with in late December 2019 with postcard flyers that were mailed to all property owners in the expansion area. The postcards were informational, but also included an invitation to a presentation, with question-and-answer session, that was held at 7pm on January 20, 2020 at Emmanuel Lutheran Church. This meeting was also promoted on the WCNA Facebook page.

In January, February, and March of 2020, the neighborhood association worked to obtain signatures of support on the petition to create the LHD expansion area. Fifty percent of the owners had signed the petition at end of March 2020, just as the COVID-19 pandemic made the effort much more difficult. The WCNA made a final push for additional signatures, and achieved a percentage of 56% signed in favor at the end of April. The WCNA submitted the petition signature pages, a map, and a spreadsheet of the ownership names, addresses, etc. on April 27, 2020. At the time Indiana and city government remained under COVID-19 lockdown. The HPC staff accepted the petition, with the understanding that it was unknown when the petition could be fully processed, and furthermore, that it was impossible to predict when the petition could be scheduled for a public hearing. Based on what local government has learned about operations during the pandemic, the public hearing was scheduled for September as a virtual public hearing.

Analysis of the WCNA local historic district petition shows that among 52 people or entities that can be defined as "owners in fee simple," 55.77% of the property owners (or 29) in the proposed LHD area signed in favor of the designation, while a combined 44.23% (or 23) either did not sign in favor or gave no response. A significant number of the 23 received notice but did not respond.

Review of the designation request was scheduled for September 28, 2020 and in compliance with Indiana Code 5-3-1 a public notice announcing the proposed designation appeared in the Fort Wayne Journal Gazette on September 1, 2020. As of September 22, staff had received no comments in writing in regard to the proposed designation from owners within the delineated area.

Staff Comments:

Section 151.10-13 of Fort Wayne's Municipal Code allows for the designation of historic districts. In applying the criteria set forth in the ordinance, it has been determined by staff that the subject area, as a part of the existing West End Historic District, listed in the National Register, meets Criterion (1) "(Is) associated with the events that have made a significant contribution to the broad patterns of our history." Staff also finds that the subject area meets Criterion (3) "Embod(ies) the distinctive characteristics of a type, period, or method of construction...or that represent a significant and distinguishable entity whose components may lack individual distinction."

Description:

The West Central area that is within the National Register historic district is significant for its unique collection of homes that represent every architectural style present between 1850 and 1950. While the north side of the district served as home to many business owners and community leaders, the southern portion of the National Register district was home to working class families. Many households were supported by the various industries that stretched along the nearby railroad corridor. Along Jefferson Boulevard and south to the railroad tracks there is a remarkable collection of modest, small-scale workers cottages arranged along narrow, tree-lined, brick streets. Wilt Street in particular retains its historic character with the combination of the brick pavement and regular spacing of working class homes.

This expansion area is a showcase for two vernacular house types; both the Gable-front and the Gabled-ell types are numerous in the area. These two types compose the overall historic character of the area. There are also examples of the American Foursquare style. There is one house in the district expansion that was built within the last ten years; it is a modern interpretation of the American Foursquare style.

The Gable-front house was created by two factors, stylistic and economic, which combined to cause a shift of emphasis from the sides of houses to the gable-end. The popular Greek Revival style placed emphasis on the gable ends of buildings because the triangular shape resembled the pediments of Greek and Roman temples. Greek Revival buildings often had a gable-end entrance in order to simulate a temple front. Simultaneous with the popularity of the Greek Revival style, urban areas in the United States grew tremendously. Urban land became more valuable; city lots became smaller and narrower. The narrower gable-front house allowed the largest house possible on a small lot. Gable-front houses were built nationwide for generations and were adapted to a variety of materials and styles.

The Gable-front may be either two stories or one story (often called a Gable-front cottage), with the gable-end and entrance facing the street. The floor plan sometimes included an entrance hall, with stairway, which ran to the rear of the house. First floor rooms were often parallel with the hall, with parlor at the front, dining room, and the kitchen at the rear. Exteriors could be plain, or decorated with popular architectural styles from Greek Revival to Craftsman. Simple entry or full-width porches were often placed on the facade.

The Gabled-ell can be found nationally, on farms as well as in urban areas. The Gabled-ell uses a similar plan to the earlier Upright-and-Wing house type; however the small wing (or "ell") is equal or nearly equal in height to the two story upright portion of the house. The roof is typically a cross-gable. The ell does not provide the significant additional width of the wing of an Upright-and-Wing house. A porch and entry door(s) are often placed in the corner created by the intersection of the front gable and the ell. The porch is usually parallel with the front gable portion of the house. This overall arrangement provides the house with an integrated and compact "L" or "T" shape to the ground plan. The Gabled-ell Cottage is simply a gabled-ell with only one to one-and-a-half stories; Gabled-ell Cottages are found in the expansion area.

The house at 1302 Jackson is a notable exception to the vernacular house types in the expansion area. It is a much larger home, and it mixes the massing of both the American Foursquare and Queen Anne styles. It has numerous Free Classic details and an impressive dormer with a Palladian window.

HPC staff walked the area and shot new photos of all the houses in the area for the HPC archive in May, 2020. This allowed an assessment of the current conditions of the area. A quick visual survey along with documentation was accomplished; however it was not a full study of each structure. The expansion area remains generally consistent with past surveys, and the newest survey data compiled by the Indiana state historic preservation office indicates that the houses in the expansion area have remained relatively stable in historic inventory ratings, when comparing the 1996 and 2019 surveys.

Staff Recommendations:

For the reasons stated above, staff recommends that the Historic Preservation Commission approve the petition, recommend the proposed West Central Local Historic District expansion area for local historic district designation, and submit the required documentation to the Fort Wayne City Council for final approval pursuant to Chapter 151 of the Municipal Code.
