

That the area described as follows is hereby designated an R1 (Single Family Residential) District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana: The South 220 feet of the West 400 feet of the West ½ of the Southwest ¼ of Section 16, Township 30 North, Range 13 East, in Allen County, Indiana. and the symbols of the City of Fort Wayne Zoning Map No. T-11 (Sec. 16 of Adams Township), as established by Section 157.082 of Title XV of the Code of the City of Fort Wayne, Indiana is hereby changed accordingly. If a written commitment is a condition of the Plan Commission's recommendation for the adoption of the rezoning, or if a written commitment is modified and approved by the Common Council as part of the zone map amendment, that written commitment is hereby approved and is hereby incorporated by reference.
