SECTION 1. All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for open cut excavation replacement of two areas of combination sewer that are fully deteriorated in the Pettit-Rudisill Neighborhood. The replacement includes approximately 1,800 linear feet of 12" sewers, 7 manholes, and 5 catchbasins

involving a total cost of FOUR HUNDRED FIFTY-FIVE THOUSAND NINE HUNDRED AND 00/100 DOLLARS - (\$455,900.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.

AGREEMENT BETWEEN OWNER AND CONTRACTOR ON THE BASIS OF A STIPULATED PRICE

Resolution 76735 Work Order 76735

THIS AGREEMENT is by and between the <u>Board of Public Works of the City of Fort Wayne, Indiana</u> (hereinafter called Owner) and <u>Bunn, Inc</u> (hereinafter called Contractor).

Owner and Contractor, in consideration of the mutual covenants hereinafter set forth, agree as follows:

ARTICLE 1 - WORK

1.01 Contractor shall complete all Work as specified or indicated in the Contract Documents. The Work is generally described as follows:

The open cut excavation replacement of two areas of combination sewer that are fully deteriorated in the Pettit-Rudisill Neighborhood. The replacement includes approximately 1,800 linear feet of 12" sewers, 7 manholes, and 5 catchbasins.

ARTICLE 2 - THE PROJECT

2.01 The Project for which the Work under the Contract Documents may be the whole or only a part is generally described as follows:

Pettit-Rudisill Neighborhood Sewer Open Cuts

ARTICLE 3 - ENGINEER

3.01 The Project has been designed by Fort Wayne City Utilities Engineering. Throughout these Contract Documents, the term Engineer is used. Engineer is to act as Owner's representative, assume all duties and responsibilities, and have the rights and authority assigned to Engineer in the Contract Documents in connection with the completion of the Work in accordance with the Contract Documents. Owner will advise Contractor prior to issuance of Notice to Proceed as to who will serve as Engineer.

ARTICLE 4 - CONTRACT TIMES

- 4.01 Time of the Essence
 - A. All time limits for Milestones, if any, Substantial Completion, and completion and readiness for final payment as stated in the Contract Documents are of the essence of the Contract.

- 4.02 Days to Achieve Substantial Completion and Final Payment
 - A. Milestone 1: All Work, with the exception of final restoration of the asphalt and grass, shall be completed 120 days after the date when the Contract Times commence to run as provided in Paragraph 2.03 of the General Conditions.
 - B. The Work will be substantially completed within 150 days after the date when the Contract Times commence to run as provided in Paragraph 2.03 of the General Conditions, and completed and ready for final payment in accordance with Paragraph 14.07 of the General Conditions within 180 days after the date when the Contract Times commence to run.
 - C. Definitions of Substantial Completion for this Work shall consist of the point in time when all work, including asphalt pavement and final seeding, has been installed and successfully tested and/or televised.

4.01 Liquidated Damages

B. Contractor and Owner recognize that time is of the essence of this Agreement and that Owner will suffer financial loss if the Work is not completed within the times specified in Paragraph 4.02 above, plus any extensions thereof allowed in accordance with Article 12 of the General Conditions. The parties also recognize the delays, expense, and difficulties involved in proving in a legal or arbitration proceeding the actual loss suffered by Owner if the Work is not completed on time. Accordingly, instead of requiring any such proof, Owner and Contractor agree that as liquidated damages for delay (but not as a penalty), Contractor shall pay Owner \$1000 for each day that expires after the time specified in Paragraph 4.02 above for Milestone 1 and Substantial Completion until the Work is substantially complete. After Substantial Completion, if Contractor shall neglect, refuse, or fail to complete the remaining Work within the Contract Time or any proper extension thereof granted by Owner, Contractor shall pay Owner \$500 for each day that expires after the time specified in Paragraph 4.02 above for completion and readiness for final payment until the Work is completed and ready for final payment.
