A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA, APPROVING THE PURCHASE OF LAND BY THE FORT WAYNE REDEVELOPMENT COMMISSION FOR MORE THAN THE AVERAGE OF TWO APPRAISALS (AVENUE OF THE AUTOS)

WHEREAS, the Fort Wayne Redevelopment Commission (the "Commission") desires to purchase certain parcels of real property located at 505 Avenue of Autos, Fort Wayne, Wayne Township, Allen County, Indiana 46804 (Parcel Number 02-12-06-402-002.000-076) ("KEL-014 Property"), 633 Avenue of Autos, Fort Wayne, Wayne Township, Allen County, Indiana 46804 (Parcel Number 02-12-06-402-003.000-076) ("KEL-011 Property"), and 811 Avenue of Autos, Fort Wayne, Wayne Township, Allen County, Indiana 46804 (Parcel Number 02-12-06-452-001.000-076) ("KEL-012 Property"), and more particularly described on Exhibit A hereto, together with all improvements and landscaping located thereon, and any and all rights, privileges, easements, rights of way, benefits, agreements, development rights and appurtenances thereunto belonging (collectively, the "Property"); and

WHEREAS, the purchase price negotiated with the Real Estate Investment Trust (REIT) that owns the Property is \$7,310,000, which exceeds the greater of the two appraisals of fair market value of the Property by \$330,000; and

WHEREAS, as a result, IC 36-7-14-19.5(b)(2) requires the Common Council ("Common Council") of the City of Fort Wayne, Indiana (the "City"), acting as the legislative body of the City, to approve the purchase of the Property by the Commission; and

WHEREAS, the Common Council also desires to authorize the purchase of the Property pursuant to Fort Wayne Municipal Code §37.18.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA, AS FOLLOWS:

- 1. The Common Council, in its role as legislative body of the City, hereby authorizes the purchase of the Property pursuant to IC 36-7-14-19.5(b)(2) by the Commission for a price that exceeds the greater of the two appraisals of the fair market value of the Property.
- 2. The Council also authorizes the purchase of the Property and execution of a Real Estate Purchase and Sale Agreement by the Commission pursuant to Fort Wayne Municipal Code §37.18.
- 3. This Resolution shall be binding and in full force and effect from and after the time it has been adopted by Common Council, approved by the Mayor and otherwise executed and delivered in accordance with any and all laws appertaining thereto.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.

FIRM #0020 SET FLUSH AT THE POINT OF REVERSE CURVATURE OF A REGULAR CURVE TO THE LEFT HAVING A RADIUS OF 70.0 FEET; THENCE NORTHEASTERLY, ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 68.25 FEET, BEING SUBTENDED BY A LONG CHORD HAVING A LENGTH OF 65.58 FEET AND A BEARING OF NORTH 03 DEGREES 41 MINUTES 29 SECONDS EAST, TO A 5/8-INCH REBAR FOUND FLUSH; THENCE NORTH 89 DEGREES 50 MINUTES 00 SECONDS EAST, NOT TANGENT TO THE LAST COURSE, A DISTANCE OF 385.09 FEET TO THE TRUE POINT OF BEGINNING, CONTAINING 4.104 ACRES OF LAND.
