Division of Public Works, Street Light Engineering/Operations Division is seeking approval for an increase for our Purchase Order amount with ESL Spectrum, Inc. not to exceed \$250,000 for 2022.

This increase is being requested for the following reasons:

- 1) Public Works would like to establish a PO with ESL Spectrum to purchase lighting products for various projects in the city.
- 2) Since products are from a sole source vendor, Public Works is requesting no bids are needed.
- 3) ESL Spectrum has provided to Public Works Sole Source provider letters from 5 different lighting product vendors used by Street Light Operations.
